IN THE MATTER OF ROAD VACATION ROAD 3340:

Local resident Paul Meyers appeared at 0900 for the hearing at the start of the term for the proposed vacation of a segment of County Road 3340. Accommodations for a turnaround at some point west of the driveway for the residence addressed as 15870 were emphasized; just west of the driveway there may be slightly less slope than otherwise, compared to the low spot is quite a bit farther west. The Commission favored the construction of a "hammerhead" terminus as it is more easily constructed and maintained than a round cul-de-sac. Presiding Commissioner Verkamp said that after consensus with the acting Road Superintendent Mark Case regarding the specifications and location of the turnaround area, and following posting pursuant to RSMo 228.110, this would be read again on the first day of the next term, being Tuesday, April 5, 2022 at 10:00 a.m.Acting Road Superintendent Mark Case and Michelle Bock of the Road Department entered at 0940 and joined in the discussion of the creation of a turnaround area. Local resident Chester Kojro entered at 0950. The eastern terminus of Road 3330 was then discussed; the remaining limb of the road had not only been gated but there had been no turnaround constructed, which was clearly described in road vacation documents. One of the petitioners was believed to barely live in Meramec Township and Myers was advised to secure another signatory. Myers left at 1005 and Case followed soon after but then returned.

IN THE MATTER OF EXTENSION BUDGET HEARING:

Rachel Buenemann, County Engagement Specialist; Maretta Diestelkamp, Extension Council Chairperson and Jean Day, Nutrition Program Associate of the University Extension entered at 1000 for their budget hearing. Diestelkamp supplied the Commission with a letter outlining community participation with Extension programs such as Tai Chi for Arthritis and Cooking Matters, reaching 600 participants and 4-H. The Extension is asking for an increase in county funding to bring their assistant up to par with other county employees. Diestelkamp informed the Commission that the annual banquet will be Thursday, February 17. Buenemann then provided information on a beginning tree syruping program offered by Sarah Havens, the forester. She also plans classes on timber foresting as well as a continuation of her Women Owning Woodlands programs. Collector Faith Barnes entered at 1020 right before the Extension employees left.

IN THE MATTER OF COLLECTOR:

COLLECTOR, Continued:

Barnes provided a report of the tax collections during the final days of December, 2021 with her office being open on the legal holiday of Friday, December 31. No bailiff coverage was available as had been originally expected.

IN THE MATTER OF ROAD DEPARTMENT BUDGET:

Case said he hoped for a work plan for the Road Department that would lay out a project list for asphalt and chip & seal, perhaps for multiple years. He said this plan might not be finalized before his budget was completed. Case said using the asphalt lay-down machine for patching supplied more uniform and satisfactory results than patching with the road grader. Case provided an example of the 1.98 miles of County Road 7160, starting at 0" increasing to 1.75" and then tapering to 0"again, with about 600 tons of asphalt at \$35,000.00. Bock supplied a chip & seal list of targeted county rods in the 1,000's and some in the 3,000's including 3610 and 3620 in the Boy's Time area. Additionally, the balance of the 7,000's and 8,000's which were not addressed this past year totaled about 40 miles, comparable to what was done in 2021. With an earlier start, there could be asphalt patching followed by a week of break for the workers from the very hot work with the lay-down machine; during this time the patch could cure prior to returning for chip & seal. There was a mention of the Use Tax and its potential dedication only to roads. Bock detailed the effect of COLA's of various percentages, targeted at 8%. After discussion, a 5% COLA across the board with 3% variable merit increase was recommended. Overlay roads were discussed; Commissioner Hicks pointed out that Road 4160 is gravel but is the primary shortcut between Highways F and 68, thus the appeal of hot-deck. Road 4270 is actually private property beyond a described cul-de-sac. Several other roads were then discussed.

IN THE MATTER OF ADULT ABUSE BOARD:

As moved by Commissioner Hicks and seconded by Commissioner Auxier the appointment of Paul Lambert to the Adult Abuse Board was approved.

IN THE MATTER OF UNEMPLOYMENT CLAIM:

Contesting an unemployment claim by an employee who voluntarily separated from the county employment in July, 2020 was approved as moved by Commissioner Auxier and seconded by Commissioner Hicks.

IN THE MATTER OF USGS:

The memorandum of understanding was approved as moved by Commissioner Hicks and seconded by Commissioner Auxier. This codifies the storage of USGS Data in the Courthouse basement and use of the facility there as an alternate site in the case of natural disaster impacting the USGS Facility.

Childers' emphasis was the wide fluctuation in court activity due to communicable disease restrictions because of COVID-19, and the training opportunities needed by both her new and established employees, which have been severely curtailed. Wilson said that he thought redistricting for Missouri's 8th Congressional District would add Pulaski, Laclede and a good share of Taney Counties and remove southern Jefferson County.

IN THE MATTER OF REAL ESTATE COURT ORDER:

The Commission reviewed Real Estate Court Order Certificate 2021000031 for parcel number 2021-9627 abating a nuisance fee of \$9,590.87 as requested by the City of Rolla. The city was satisfied that this issue had been resolved; it was approved as moved by Commissioner Auxier and seconded by Commissioner Hicks.

IN THE MATTER OF BUDGET HEARING:

IN THE MATTER OF COUNTY ROAD 3330:

This matter was discussed again briefly.

IN THE MATTER OF AMERICAN RESCUE PLAN ACT (ARPA):

Kelly Sink from MRPC entered at 1000 and provided a proposal for ARPA funds from Phelps Connections for Seniors (PCS) which will, in part, permit consolidation of Aging Best a/k/a CMAAA and PCS as a new physical facility is established. There is need for site control before granting agencies will be agreeable to funding. Sink said that the project is over \$1,000,000 all told. The contract on the building is "for \$450,000." Sink thought there would have to be a more formal process of two appraisals; PCS would then take title to the building. Furthermore, Sink provided one copy of each of the 9 water & sewer requests and had a spreadsheet of their recommendations. Sink's expectation is that Department of Natural Resources (DNR) will have additional funds available for funding which may be detailed at the time of the governor's state of the state address. Sink thought there would be grants, loans, and grant/loans. City of St. James supplied four projects prioritized by them. #1 is third lift station; #2 is the clarifier (state revolving fund is approved; the amount was 2.4 million) #4 was line replacement eliminating cast iron pipe from their water tower. As ARPA is federal funds, the entities have to go through RFP process for engineering. Sink said there were cities around the state which did not accept ARPA funds and when these funds are redistributed the award amounts may increase for, say, Edgar Springs which in total received \$39,000 or Newburg which in total received \$92,500. Michelle Bock of the Road and Bridge Department entered at 1020. As the water/sewer projects would consume all of the total county ARPA award, fully funding them precluded funding the senior center. St. James is said to have received \$700 K which they are using on the police department and possibly on the visitor's center. Responding to a question from Presiding Commissioner Verkamp, Sink said that the city of Edgar Springs provides the sewer for the town and all lift stations; the "sludge truck" needs to be replaced as does their collection system. Engineering for a project for the city of Newburg at \$75,000 was deemed important. Smoke testing of Doolittle's line along Martin Springs is what that city wants funded. PWSD #2 is asking for \$2 M but Sink thinks they might be given funding at a later date. The following tentative breakdown for the sewer/water projects funded by the first half of the County's ARPA funding was as follows:

request from Phelps Connections for Seniors for \$450,000 for the acquisition of property was approved. This will enable them to proceed with other applications for revenue. Sink left at 1050.

IN THE MATTER OF ROAD 3330:

Bock said that Mr. Scott Dickerhoff had never vacated the portion of 3330 which is currently east of, and made inaccessible by, a gate across the road. Director of Support Services, Building and Grounds Sissy Korich entered at 1050.

IN THE MATTER OF HVAC CONTROLS:

Korich said that she will be generating an RFP for HVAC Controls to submit for bid to be published Thursday January 13. She believed problems getting parts are a certainty.

IN THE MATTER OF 2022 BUDGETS AND SALARIES:

The Commissioners deliberated over COLA's and believed that budgets should reflect a 10% increase in the salary lines approved the prior year with 5% of this an across-the-board COLA and 5% discretionary for the office holder/department head based on merit. Elected Officials, statutorily, may only receive a COLA and only if given county-wide. The clerk will notify elected officials of this.

IN THE MATTER OF TREASURER:

Treasurer Carol Green, board member of Phelps Connections for Seniors, entered to express her appreciation for the funding support through ARPA for the senior center supplied by the County.

IN THE MATTER OF ACCOUNTS PAYABLE:

The Commission reviewed and approved payment of 7 invoices in the amount of \$23,604.89 for contract pay and \$533.18 for Senior Companions which is their employee reimbursement and bills, funded 100% by their federal grant.

IN THE MATTER OF PASSPORT ASSESSMENT:

The clerk reported that the recent assessment of the Passport Acceptance Facility had concluded "...that the facility is organized and continues to demonstrate a solid commitment to a quality passport acceptance program. The facility is compliant with passport acceptance guidelines," and there were "...no facility action items recommended."

IN THE MATTER OF COUNTY CLERK TURNOVER:

The clerk reported her fee turnover of \$406.00 and passport fees of \$1,855.00 for December, 2021 pursuant to RSMo 50.370.

IN THE MATTER OF CYBERSECURITY COVERAGE:

The Commission suggested that the Sissy Korich, Director of Support Services, Building and Grounds, provide guidance on apportioning this approximately \$16,000 premium.

IN THE MATTER OF LIQUOR LICENSES:

Subsequent to changes in the law, the Commission expressed their intent to follow statutes with respect to types of licenses.

Billy Harris of Edgar Springs, County Road 6210, entered to inquire about dust control for his road. He asked about application of chemical dust control for the road and was told the county did not utilize such products; rather, the approach was to chip & seal gravel roads. Harris also has difficulty with water runoff of the road toward his rather long driveway apron on the south side of a curve with north-facing concavity. Commissioner Hicks obtained his contact information and let him know he planned to visit the area.

IN THE MATTER OF COUNTY RECORDER BUDGET HEARINGS:

County Recorder of Deeds Robin Kordes presented her budget requests for Fund 200-2010 and Fund 510. Her office is among the only Recorder's offices in the state which are fully digitized.

IN THE MATTER OF COUNTY TREASURER BUDGET HEARINGS:

County Treasurer Carol Green presented her budget requests for Fund 200-2005.

IN THE MATTER OF EMPLOYEE HEALTH INSURANCE:

The Commission received and reviewed the Benefit Management Report (BMR) for CY 2021 from Group Benefit Services in Springfield. The loss ratio was 75%; Reserve Account Balance end of year was \$643,022.61. In terms of percentage of the plan cost to the county, medical, dental, and vision claims were 53%, 2% and 1%, respectively. Pharmacy Claims were 11%; reinsurance premiums were 27%. The balance of the cost was 2% for utilization review/LCM fees and 3% for TPA fees.

Sufficient funding for the upcoming completion of the courthouse HVAC project will be taken from either Public Facilities Fund 900 or from the Jay White Estate Fund, Fund 906. Korich reviewed her 200-2003 budget line by line, and left at 1100.

IN THE MATTER OF PAYROLL:

The Commissioners reviewed and approved payroll for 1/14/21. Net wages were \$210,542.60; federal and state withholdings were \$65,791.70 and \$8,710.50, respectively.

Collector Barnes entered at 1000 to present her Fund 200-2006 budget. She believes her revenues will go up slightly; expenses were reviewed. Fund 850, with a revenue source of 2% fees on delinquent taxes, will contain an equipment purchase for a JagWire which will read 200 documents/minute, and will be used in processing check payments.

IN THE MATTER OF BUDGET HEARING, SHERIFF'S DEPARTMENT:

Commissioner Hicks said that the fringes would need to be adjusted as a result, and the new numbers were reviewed. Commissioner Hicks informed Stoltz that the County did not intend to provide \$75,000 of county share support as in previous years, due to more-than-sufficient funds for one year's operation of his office remaining in Fund 800; Stoltz argued that the requirement was statutory, with which the Commissioners disagreed. Commissioner Hicks said that the Assessor's Fund would not be budgeted to receive \$75,000 in support from the General Fund for 2022.

Provisions for storm water conveyance were discussed; a Commissioner will inspect the area.

Presiding Commissioner Verkamp reported that the County has 12.5 grant-writing hours remaining with MRPC, after having given several for the purpose of helping Phelps Connections for Seniors (PCS) in a grant application.
