IN THE MATTER OF ASSESSOR'S QUARTERLY:

Local resident Ray Schweikhardt and the Focus reporter were present. As moved by Commissioner Auxier and seconded by Commissioner Hicks, the quarterly report was approved for submittal. Also present was Dale Martin, Executive Director of the Rolla Regional Economic Commission.

IN THE MATTER OF REAL ESTATE COURT ORDERS:

The Commission received real estate court orders numbered 2022000001 through 2022000013, which were for removal of one Rolla city NID fee and 12 Public Water Supply District #4 (PWSD #4) fees mistakenly carried over into the 2022 tax book when the clerk extended it. Commissioner Hicks had reservations. As moved by Commissioner Auxier and seconded by Commissioner Hicks these were approved. Additionally, real estate court orders numbered 2022000014 through 2022000023 were evaluated and approved as moved by Commissioner Hicks and seconded by Commissioner Auxier; these were for abatements secondary to fire and pro-ratings for acquisition of property by government and/or non-profit entities.

IN THE MATTER OF MISSOURI OZARKS COMMUNITY ACTION (MOCA):

Commissioner Hicks informed the reporter that he had forwarded on a schedule of events involving the MOCA van.

IN THE MATTER OF ROADS:

Michelle Bock of the Road Department entered at 0915 and briefly discussed work near Roads 3560 and 3570.

IN THE MATTER OF TRANSPORTATION NEEDS:

Anne Freand of Meramec Regional Planning Commission (MRPC) entered at 0916, followed by area engineer for MoDOT Preston Kramer and Rolla city administrator John Butz at 0929.

IN THE MATTER OF SHERIFF'S GRANT, EMERGENCY MANAGEMENT PLANNING (EMPG):

Sheriff Mike Kirn made an unscheduled visit to the Commission with his new EMPG paperwork; as moved by Commissioner Hicks and

seconded by Commissioner Auxier, the contract was approved. He shared a document with the Commission but Presiding Commissioner Verkamp said it was a matter for a closed session. Kirn departed at 0934.

IN THE MATTER OF TRANSPORTATION NEEDS:

Bonnie Prigge, Executive Director of MRPC, entered at 0934. commented on the "exciting times in Missouri transportation" the region is witnessing presently. She outlined that MoDOT has asked MRPC to help with the high priority unfunded needs list, as well as to consider the BRO bridge list. She then turned the discussion over to Kramer. He felt positive about the level of federal funding for transportation, as well as increased revenues from the increased gas tax. Collector Faith Barnes entered at 0940. Working from a large spreadsheet of transportation needs provided by MRPC staff, he said the goal was to move as many of these projects to the State Transportation Improvement Plan (STIP) as possible. Kramer said he did have bad news as well, however; this was the back log of work due to "decades of underfunding" and the double-digit inflation which resulted in as much as 40% higher costs in projects. Barnes left at 0944. Subsequently Kramer thoroughly discussed the list of transportation needs. He asked if there was still the desire to pursue Ph-605, the project to widen US Highway 63 from 3 to five lanes between I-44 and University Drive. Butz was consulted; he said the city was "okay with removing" the project from the list. In an aside, Kramer said that the Transportation Alternatives Program or "TAP", there are triple the normal annual allotments in the current federal transportation bill...these mostly deal with pedestrian facilities. Presiding Commissioner Verkamp asked if these were typically sidewalks; "Or trails," said Kramer. Applications for these projects will be taken again this fall and in the fall of 2023. Kramer fielded a question about the full-depth shoulder construction methods being used on I-44; he said this made the shoulders much more suitable for any traffic diversion that might be needed. Ph-627, the Rolla Amtrak stop, is still a hope of Kramers. Ph-632, the Bridge on Route B over Clear Creek, is completed and will be dropped. The focus of Ph-642 is to address the flooding of I-44 near Jerome; Kramer thinks the region will soon suffer another flood. Ph-644 is directed at increased public transportation options; Freand spoke to this need and the studies being done with the SMTS shuttles and their use. Schweikhardt left at 1005 and local resident Beth Pross entered. Since it is the bridge in the worst condition of all the state route bridges in the county, Ph-654 for Bridge T0878 over Spring Creek on Route J was discussed in some detail. Kramer said that the Highway B/Highway 68 interchange in St. James, Ph-655, was definitely a priority in St. James. Subsequently the ranking of projects, through the state's system of tiers, was discussed. Commissioner Hicks expressed the opinion that the Highway V overpass and interchange should be a high priority, and perhaps another interchange to the east and recommended mindfulness of the need for an east bypass around Rolla. Pross expressed her concern, as a citizen frequently traveling across the Highway V area, that there is incessant

competition from truck traffic exiting westbound I-44, and westbound traffic on the north outer road attempting a left turn, either to enter the interstate on-ramps or to proceed southbound on Highway V to access Old St. James Road. She said trucks do not yield and cause prolonged waits for passenger traffic, which has begun taking the back road around the Love's McDonald site in order to enter Highway V and proceed southbound in order to achieve those goals. Considering the priorities, the Commission made no changes. Prigge then went into a intricate recounting of the multimodal list and the high priority needs list. Dan Cavender with BPJ Insurance entered at 1032. Commissioner Auxier said there is significant concern with congestion at school arrival/departure times between Highway DD and I-44; this was addressed in Ph-614(b). Commissioner Hicks said Northwye Outer Road is experiencing increased traffic and said Ph-636 and Ph-637 are worthwhile projects. Commissioner Auxier, when multimodal projects were taken up, said "...a lot of people are saying we need a bike trail between Rolla and St. James" but the group acknowledged the problems of constructing this within an outer roadway which becomes an emergency bypass route. The Rolla National Airport in Maries County, on the multimodal list, was discussed with input from Butz. Presiding Commissioner Verkamp asked how much commercial activity occurred there. After discussion of BRO and Bridge Formula Program (BFP) bridges, the three priorities in the future were believed to be bridges on Roads 2110, 8410 and 7460. Barnes briefly returned between 1108 and 1110. Kramer, Prigge, Pross, Butz and the reporter left at 1115.

IN THE MATTER OF COUNTY LIABILITY COVERAGE:

Cavender was able to discuss, for several minutes, the process underway to obtain bids on builder's risk for the jail expansion; he had spoken with PCSD Lt. Joe Taylor. He is also proceeding on the renewal process with MoPERM and perhaps Missouri Public Risk (MPR). MoPERM will not negotiate their premium. Presiding Commissioner Verkamp said he would like to see quotes before any decision is made.

IN THE MATTER OF ACCOUNTS PAYABLE:

The Commissioners reviewed and approved payment of 10 invoices for \$18,982.57 in contract pay.

FERAL HOGS, MU EXTENSION:

thousand hogs, 9800 hogs and 5500 hogs have been exterminated in years 2020, 2021 and 2022 (to-date), respectively. Crider is responsible for Phelps, Pulaski, Crawford, Dent, Texas and Shannon Counties. Criminal prosecutions of those releasing hogs into the public lands are being aggressively pursued; Crider said that pursuant to the 2021 session of the state legislature passing HB 369, originally a prescribed burn-related bill but having been amended to include ban on release of hogs into the wild state, there were felonies associated with multiple convictions of release of feral hogs. Turning to other law enforcement concerns, Crider said, "You can inspect any commercial vehicle at any time, with no probable cause." Some of the justification for this is a reported 7% positivity rate for Brucellosis. Approximately 360 or more hogs have been tested by MDC and MU Extension annually; at least 14% are felt to be directly related to hogs from Oklahoma and NE Texas. Treasurer Carol Green and Cathy Tipton returned at 1140; Crider left at 1145.

IN THE MATTER OF BANKING AGREEMENT, FSCB AND JAIL EXPANSION:

Green wanted online banking established such that loan proceeds from FSCB would be drawn down by the Treasurer's office into the County General Fund. This will allow payments for the jail expansion to pass through the financial system of the County. As moved by Commissioner Hicks, the agreement was signed by Presiding Commissioner Verkamp after it was seconded by Commissioner Auxier.

He provided a look-back at the history of the County's request, in 2014, to work with the local hospital; recounted some of the no-cost-to-insured benefits such as sleep studies; reminded all of the significant discount represented by 135% of Medicare rates; the high utilization of Phelps Health, being 82.29% of all claims; the room for improvement in pharmacy claims; the help available with the nurse navigator. He reviewed in detail the Key Performance Indicator information. Addressing the lack of

benefits to the dependents, Deren said this was very typical across the industry; the policies very typically have great benefits for the mostly employee. There is a change coming in 2023, with plans allowing for enrolling dependents not disqualifying those dependents for subsidy on the ACA Marketplace. Drug costs are significant, and increasing. Generic use is fairly high but 90 day prescriptions could increase. There are some employees on very expensive biologics; GBS believes there would be significant savings possible. Apparently the "adherence" (or compliance) with prescribed medicines could improve, especially with diabetes drugs. Asking for employee input, Deren heard from Wiese that some of the claims for flu shots through the Health Department were very slow to be reimbursed. Deren asked her to contact GBS to work on a solution for this; there is an intermediary involved. Stop-loss was then discussed. Barnes offered some comments. Deren left at 1140 after learning from Presiding Commissioner Verkamp that a competing proposal was working on the high-loss claim information that GBS had provided them.

IN THE MATTER OF AARP TAX HELP:

The clerk notified the Commission that, due to imminent demolition of the Holloway House, AARP Tax Help had asked for use of the Sky Room not only for Thursdays, but also for Mondays in the February-April 15 timeframe. The Commission was agreeable to this. Local resident Ray Schweikhardt and the Focus reporter were present.

IN THE MATTER OF LETTER OF SUPPORT, ROLLA CITY USE OF ARPA FUNDS:

Darin Pryor, P.E. of the Rolla Public Works Department and Floyd Jernigan, Parks Director made an unscheduled visit to the meeting. Jernigan said that part of the Acorn Trail needed replacement; widening from 4 to 8 feet for better ADA compliance was planned. For the \$495,000 in ARPA funds, the city can use projects completed between 3/21/2021 and the present as match; this implies all but \$66-70,000 in the match is covered. The clerk asked about future closure of parks facilities in the event of future outbreak of respiratory disease; Jernigan provided reassurances that the city would make careful decisions. After agreeing to provide a draft of the desired letter to the clerk, they left at 0920.

IN THE MATTER OF REAL ESTATE COURT ORDER, CHAPTER 100 (HARTMANN):

This court order, numbered 2022000469 (Account number 2022-62063) which reduced the personal property tax from \$417,698.70 to \$114,287.55, was approved as moved by Commissioner Hicks and seconded by Presiding Commissioner Verkamp.

IN THE MATTER OF REAL ESTATE COURT ORDER, EEZ PROPERTY:

As moved by Commissioner Hicks and seconded by Presiding Commissioner Verkamp, this court order numbered 2022000046 (Parcel number 2022-9618.32) which reduced real estate taxes from \$65,759.34 to \$26,405.74 on a hotel, was approved.

IN THE MATTER OF ACCOUNTS PAYABLE:

The Commission reviewed and approved 20 and 15 invoices in the amounts of \$115,314.29 and \$14,549.30, respectively. Also

approved were three invoices for United Missouri Bank (UMB) TIF Economic Activity Taxes ("EATS") for Rolla Westside in the amount of \$30,193.39 and the Group Benefit Services invoice for December employee health insurance coverages of \$122,661.99. Schweikhardt left at 0925 followed by the reporter. Local resident Chester Kojro entered at 0935.

IN THE MATTER OF STOP SIGN, ROADS 8170 AND 8200:

Kojro asked about the stop sign at this intersection, pointing out that a car turning north from Road 8200 after a stop might not be seen by a car traveling north on Road 8170 which would be cresting a hill just south of the intersection; it could be traveling quickly. Solutions such as a "T" intersection sign or some other sign for the northbound traffic on Road 8170 were discussed. Tonya Greven and Mike Scott of BPJ entered at 0950; Assessor Tim Kean, Phelps/Maries Health Department Director Ashley Campbell and Director of Building and Grounds Sissy Korich entered at 1000.

IN THE MATTER OF EMPLOYEE HEALTH INSURANCE PROPOSAL, BPJ:

The proposal from BPJ was discussed at length by Greven and Scott. This group had several concerns; one an employee with high claims and more-than-expected pharmacy costs for the diagnosis that BPJ had seen in the records provided (all of which were anonymized), and the other the use of specialty medications known as "biologics" (recombinant antibodies) which may or may not be amenable to patient utilization or assistance programs. Commissioner Auxier entered at 1050. Greven said that Anthem and Aetna both declined to provide fully-insured plans; they said that they "would not be competitive." Scott and Greven left at 1150. After further discussion, Commissioner Auxier moved and Commissioner Hicks seconded to change the third party administrator to that working with BPJ: UMR, a division of United Health Care. After a discussion of premiums, Commissioner Hicks moved and Commissioner Auxier seconded an increase of 5% of both the employee portions and the employer portions of the premiums, to facilitate a \$500 deductible for a very wide range of providers. There will be an employee navigator online platform for enrollment at no charge.

IN THE MATTER OF MISSOURI ASSOCIATION OF COUNTIES (MAC):

Commissioner Auxier provided a synopsis of the MAC conference.

IN THE MATTER OF REAL ESTATE COURT ORDERS:

IN THE MATTER OF PROJECT TAX EXEMPTION, ROADS 2110 AND 8010:

DOR Form 5060 was approved for NB West from 11/1 through 12/1/2022, as moved by Commissioner Hicks and seconded by Commissioner Auxier. NB West, the contractor, will not have to pay sales tax on material purchased for the project this way.

IN THE MATTER OF CORONER:

Coroner Ernie Coverdell entered for an unscheduled visit and the Missouri State Coroner's Training Fund was discussed. Presiding Commissioner Verkamp called Kathy Little, Missouri Coroner's and Medical Examiner's Association Executive Director. The makeup and vacancies on the MCMEA board were discussed.
