**NOTICE OF SPECIAL ELECTION**

Notice is hereby given that a Special Election has been called by 95<sup>th</sup> General Assembly (Second Regular Session) to be held in the State of Missouri on the 3<sup>rd</sup> day of August, 2010 for the purpose of voting on a question presented in SS SCS HCS House Bill 1764, known as Proposition C.

The ballot for the election shall be in substantially the following form:

Shall the Missouri Statutes be amended to:

- Deny the government authority to penalize citizens for refusing to purchase private health insurance or infringe upon the right to offer or accept direct payment for lawful healthcare services?
- Modify laws regarding the liquidation of certain domestic insurance companies?

It is estimated this proposal will have no immediate costs or savings to state or local governmental entities. However, because of the uncertain interaction of the proposal with implementation of the federal Patient Protection and Affordable Care Act, future costs to state governmental entities are unknown.
