Commissioner Hicks advised he would like to see someone that has been directly affected by the effects of prescription drugs being give and causing addiction in themselves or a family member that had direct effect on them. Also Hoping to have the public be just as supportive once they see the positive changes this will have on our community. In the matter of
E911 Board on Ballot:

Discussions were had on whether or not there were any E911 board positions on the April Ballot. Further discussions were had on how someone can be counted on the ballots as a write in. Clerk Johnson advised in order to be counted you have to become a certified write in which can be done in the County Clerk's office. Tim Kean from the Assessor's office entered at 9:25 am followed by Collector Faith Barnes at 9:28 am.

In the matter of Per Diem Amounts:

Kean wants to discuss the set per diem amounts. Discussions were had on how he doesn't want the employee to have to foot the bill when He sends them to a training event. Commission advised one of the few areas they have a policy is in the per diems and he advised it hasn't changed since it was put in place. Kean advised his predecessor looked up the federal per diem rates and they are higher than what the county has set. Hicks explains these policies are set in place as they have to have policy but yet they are constantly getting kick back from elected officials. Hicks also explains this is set to help offset the cost of the meals while conducting business not to fund all of your meals. Kean feels he is getting penalized for going to

training if the commission is not paying full meal reimbursements and he advised his Assessment fund is his fund its not General Revenue. Hicks advised your assessment fund has been supplemented by General Revenue for 10 years with the exception of the last 2 years. Stites advised after listening to this discussion she feels there is a conflict of information. Kean advised his understanding was in place from his predecessor. Discussion on have Kean or Barnes seen the policy referencing the per diems and they both advised no. Barnes advised the assessor and collector have separate funds so they feel they should not have to follow a per diem policy. Kean advised MAC says you need to follow the State amounts set and shows Commission the printout. Stites advised the commissioners need to sit down and look at these amounts and come to a decision on whether or not there needs to be a change. Bock advised when she started with the county there was emails sent out that stated you will only be reimbursed up to the set amount, nothing over that amount will be reimbursed. Kean feels if it is a mandated training he feels that employee should be fully reimbursed, if it's a voluntary training he understands that no more than the allotted reimbursement should be paid. Stites explains we need to have an open line of communication and we need to have a policy in place to provide to everyone. MRPC Flooding inspections:

The Commission received an e-mail from MRPC to say that they would be inspecting properties in the County where flood damage was reported from last weekend (3/25-26).

In the matter of
Route D Bridge, Jerome:

The Commission discussed property owner plans to fill washed-away land with rock southwest of the Route D bridge over the Gasconade River in Jerome.

In the matter of Opioid Lawsuit Settlement Advisory Committee:

Discussion was had of the proposed number and make-up of the advisory committee on expenditure of the opioid manufacturer's settlement funds. Commissioner Hicks moved to approve a draft mission statement for the advisory committee, Commissioner Stites seconded, motion carried.

The Commission made a phone call to Jamie Meyers of Behavioral Health by speaker phone. The mission statement was read to Mr. Meyers and the Commission mentioned that the advisory committee might consist of 9 people, including someone who has been personally affected by opioid addiction.
