**Proposition R31-1**

Shall the Rolla School District No. 31 of Phelps County, Missouri board of education borrow money in the amount of \$4,000,000 for the purpose of constructing, renovating, improving, furnishing and equipping school facilities of the District, including:

- Constructing additional classrooms at the High School to accommodate the movement of the 9<sup>th</sup> Grade students to the High School,
- Installing safety and security improvements, and
- Expanding the early childhood program for each Elementary School

and issue bonds for the payment thereof resulting in no increase to the debt service levy?

If this proposition is approved, the debt service levy of the District is estimated to remain unchanged at \$0.25 per one hundred assessed valuation of real and personal property.

Shall the Rolla School District No. 31 of Phelps County, Missouri board of education, be authorized to increase the operating tax levy ceiling of the District by:

- \$0.10 per \$100 of assessed valuation for tax year 2015,
- \$0.10 per \$100 of assessed valuation for tax year 2016,
- \$0.05 per \$100 of assessed valuation for tax year 2017

for the purpose of paying ongoing operating costs of the District?

If this proposition is approved, the adjusted operating tax levy of the District is estimated to be \$3.0612 per \$100 of assessed valuation in tax year 2015, \$3.1612 per \$100 of assessed valuation in tax year 2016 and \$3.2112 per \$100 of assessed valuation in tax year 2017 taking into account the Proposition C rollback resulting from sales tax revenue allocated to the District from the State of Missouri.
