ST. JAMES ELEMENTARY SCHOOL  
IMPROVEMENTS**

Shall the Board of Education of the St. James R-1 School District, Missouri, borrow money in the amount of Three Million Seven Hundred Thousand Dollars (\$3,700,000), resulting in no estimated increase to the debt service property tax levy, for the purpose of providing funds for Lucy Wortham

James Elementary School to complete safety and security improvements by enclosing walkways; the construction, equipping, and furnishing of additional classrooms, new cafeteria and kitchen at the elementary school; to renovate the existing cafeteria into classrooms; to complete roof repairs; and restructure the administrative office space for a secure main entrance; to the extent funds are available, and issue bonds, a portion of which may include Qualified School Construction Bonds and Qualified Zone Academy Bonds in an amount not to exceed the allocation from the Missouri Department of Elementary and Secondary Education, for the payment thereof? If this proposition is approved, the adjusted debt service levy of the School District is estimated to remain unchanged at \$0.53 per one hundred dollars of assessed valuation of real and personal property.
