IN THE MATTER OF ROLLA WEST TIF:

Rolla resident Tom Sager presented his opposition to the TIF development, again, to the Commission.

IN THE MATTER OF RAILROAD AND UTILITIES:

The clerk presented the 2016 Statement of Railroad and Utility Property, Form 40, as she reported to the State Tax Commission.

IN THE MATTER OF 1972 JAIL:

Sheriff Lisenbe discussed the pending feasibility study by Integrity Engineering, Inc. of refurbishing the 1972 jail for return to use. He mentioned an estimated cost of \$14,500. The Commission discussed with him his freedom to negotiate and some aspects of the contractual agreement process, including a consultation with the prosecuting attorney.

IN THE MATTER OF ROAD 3240:

Speed limits in general and specifically for Road 3240 were discussed. On a motion by Commissioner Stratman, seconded by Commissioner Hicks, the speed limit on Road 3240 was set by ordinance at 35 mph. This will be shared with Mo DOT and the Missouri Highway Patrol.

IN THE MATTER OF FEMA:

Superintendent of Roads Walter Snelson reported that FEMA would not pay his administrative costs to assess the December flood damage which were incurred prior to the Governor's disaster declaration, which came nearly a month later. He pointed out the folly of waiting for another deluge after the 11 inches of rain of late December, when it would become impossible to distinguish the effects of one storm system versus another. He also emphasized that there was risk to life and property unless some emergency repairs were undertaken; assessment and documentation of the damage, before urgent road repair work was done, was essential. He estimated that almost \$8,000 in direct administrative costs was being denied; he will forward correspondence from FEMA to Commissioner Hicks.

IN THE MATTER OF PROSECUTOR EQUIPMENT PURCHASE:

Prosecuting Attorney Brendon Fox and Linda Morris of the prosecutor's office spoke with the Commission about ordering automatic external defibrillators (AED's) for their office and perhaps two others, one each for the first and third floors. Because of a health concern in his office, he wishes to acquire one. There are already two within the circuit court office area, accessible to the court bailiffs, and there is one within the Phelps Maries Health Department area. Health Department Director Jodi Waltman has a written policy for use which Fox would use as a template. He believes one employee per office would need to be certified, at a minimum, requiring a half day of training every two years. These units cost \$1,658 each, and would be funded from the Prosecutor's Drug Fund. Commissioner Hicks asked whether this would cause the county to incur additional liability, and Fox said it would not. Because of the \$4,500 bid thresh hold for purchases from a single vendor within a 90 day period, Fox will go about purchasing two now and will start training.

IN THE MATTER OF PERSONAL PROPERTY COURT ORDERS:

The Commission reviewed and approved amendments to correct court orders numbered 1824, 1826, 1837, 1840. The Commission reviewed and approved court orders 1841, 1842, 1843 for March 2016 which increased assessed values by \$3,340 for 2013, \$81,840 for 2014, and \$537,750 for 2015. Court order 1844, 2012 outlawed personal property with total valuation of \$1,419,210, was reviewed and approved. Court orders 1845 and 1846, personal property court orders for Phelps County R-3 School District abatements of overcharges, were reviewed and approved.

IN THE MATTER OF EQUIPMENT SALES:

Charlie Thomas from Viebrock Sales & Service LLC visited the Commission.

IN THE MATTER OF REAL ESTATE COURT ORDERS:

PCCo 2015-0030, 2014-0014, and 2013-0046, all correcting Lots 2-6 of Hy Point West to tax-exempt status through RCDC, were approved.

IN THE MATTER OF SALES TAXES:

In the absence of Treasurer Carol Green, the clerk gave the sales tax report for June. Sales tax revenue for the County 0.5% sales tax was \$280,536.16 and for the Law Enforcement 0.375% sales tax was \$210,391.62, up 7.12% from one year prior, up 3.79% rolling twelve months, and up 4.74% year-to-date compared with the first 6 months of 2015.

IN THE MATTER OF UNIVERSITY EXTENSION:

Phelps County Extension Council member and Commissioner Larry Stratman reported on a recent meeting of the council at which a 5 percent cut in the University-wide budget which included the Extension was revealed. This will mean the loss of one position in Phelps County, that of the horticultural specialist. Stratman also reported that the boundary line in Extension Council elections may be eliminated, such that the representatives will be elected from the county at large.

IN THE MATTER OF ROAD 5090:

Resident Lou Moss corresponded with the Commission regarding the condition of the road; he suggested that leveling was needed.

IN THE MATTER OF VACATION ACCRUALS:

The clerk notified the Commission that the department heads had received notice of their employees' accruals.

IN THE MATTER OF NORTHWYE OUTER ROAD:

Local resident Monte Willy came to report that the utilities which would need to relocate were reaching agreement. These two utilities will likely put lines in separate trenches.

IN THE MATTER OF 7050 BRIDGE:

Delivery of the precast concrete beams is anticipated on 6/21/16. The beams are approximately 16 tons each and can only be transported singly on flatbeds. A landing for the crane may need to be built.

Accounts payable for 55 invoices for a total of \$92,196.65 was reviewed and approved.

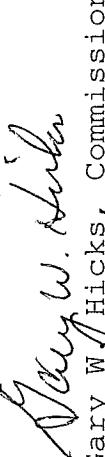

**IN THE MATTER OF
FRIDAY BACKPACK PROGRAM:**

Local resident Faith Ann Barnes presented information about her program, the Friday Backpack Program, to the Commission. Entering its 10th year, this effort provides nourishing food to school children who may encounter needs over the weekend due to working or absent parents or financial hardships. The expenditures are now in the range of \$75,000 to \$90,000 for the purchase of food with approximately 430 children per week provided with food last year. She receives no government funding, and approximately 75% of her funding comes from the Rolla area. Because of the increased utilization with a decrease in funding as the program has aged, she would like to investigate other sources and inquire about receiving some grant writing hours from the county with MRPC. Presiding Commissioner Verkamp will put her in touch with them.

**IN THE MATTER OF
1972 JAIL:**

Phelps County Jail Administrator Lt. Matt Shults, stated that the only timely submission for the feasibility study to return the jail to service was received from Integrity Engineering, Inc. Commissioner Hicks moved, Commissioner Stratman seconded, to award the feasibility study contract to Integrity Engineering.

**IN THE MATTER OF
SENIOR COMPANIONS:**

Director of Senior Companions Jan Boatright received notice of her grant award in the amount of \$332,150 from the Corporation for Neighborhood and Community Service. 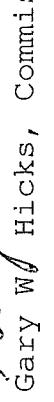

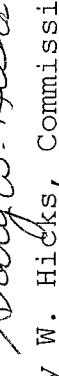

IN THE MATTER OF MOTOR GRADER LEASE:

Gerry O'Bryan and Steve Horstmann of Caterpillar Financial Services Corporation met with the Commission and Superintendent of Roads Walter Snelson regarding the lease of the road grader which had been delivered yesterday. IN THE MATTER OF NORTHWYE OUTER ROAD:

Darin Pryor, PE, with the city of Rolla attended to discuss utility relocation at the site of the Northwye Outer Road. He said that the Uniform Utility Relocation Act, the law to follow when obtaining public works easements from property owners includes those owners receiving, and acknowledging receipt of, the fact that they are eligible for compensation. Prevailing wage rates will also apply to the work. Pryor intends to meet with MRPC, Intercounty Electric, and Fidelity Communications representatives. Pryor has an engineer's estimate of the dirtwork contract and will send this to Presiding Commissioner Verkamp.

IN THE MATTER OF GROUP BENEFIT SERVICES:

The Commission reviewed the 2016 Benefits Management Report, which showed that through May 2016, with YTD Claims Subject to Aggregate of \$388,763.00 compared with YTD Aggregate Liability of \$301,482.90, the Loss Ratio was 1.29%. There were particularly large medical claims in May. Also the reinsurance premiums paid to date were \$80,825.96 with claims over specific, or reinsurance claims paid out to date, of \$67,644.12.

IN THE MATTER OF FLOODPLAIN ADMINISTRATION:

Costs having increased, the Floodplain Technical Assistance Contract with MRPC was increased to a total of \$11,000 on a motion by Commissioner Hicks, seconded by Commissioner Stratman.

IN THE MATTER OF BIDS ON CERTIFICATES OF DEPOSIT:

The Commission received bids for Certificates of Deposit for the following funds: MHHA - \$225,000; Unemployment Fund - \$100,000; Sheriff's Drug Forfeiture Fund - \$700,000; Law Enforcement Debt Service Fund - \$100,000; Prosecutor's Drug Forfeiture Fund - \$150,000; Courthouse Sales Tax Fund - \$600,000; Jay White Fund \$150,000. Bids were requested for 6 and 12 month intervals; Sheriff and Prosecutor's Drug Funds were to have "no penalty" and were bid separately. The bids received were as follows:

BIDS ON CERTIFICATES OF DEPOSIT, Continued:

Treasurer Carol Green discussed some aspects of the funds and the bids proposed. On a motion by Commissioner Stratman, seconded by Commissioner Hicks, the bid was awarded to the high bidder for the 12 month term, First State Community Bank.

IN THE MATTER OF SEWER SERVICE:

Local resident Rene Elrod, living on Road 8070, came to ask about permitting and connecting to the city of Rolla sewer. She said her property was 1.6 miles outside the city limits. Details such as utility easements, county rights of way, and DNR's requirement for construction permits were discussed. Elrod said she understood that 2 pump stations and 4 relief valves with 11,500 feet of pipe would be required; she has retained an engineering firm. Boring underneath concrete drives will be needed. Presiding Commissioner Verkamp said it was within the Commission's power to give her permission within rights of way; Commissioner Hicks said contours, ditches, etc. would need to be restored to original condition and a surety bond would also be required. Verkamp also said Elrod should speak again with city of Rolla engineer Steve Hargis. Also discussed was the necessity of crossing 5 creeks with the planned 2.5 inch line, and if she has to bury line, she will have to protect it with steel conduit or concrete due to the debris potentially washing down the creeks; further, the U.S. Army Corps of Engineers may become involved. Verkamp emphasized the importance of a full set of plans.

IN THE MATTER OF ACCOUNTS PAYABLE:

The Commission reviewed and approved payment of one invoice for \$1,045.40.

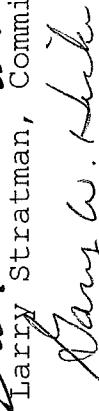
