ROAD 7550:

Superintendent of Roads Walter Snelson said MoDOT had done the final inspection of Road 7550 and they seemed very satisfied that 27 and not 3 culverts had been replaced. There is a 60 day period to turn in all paid invoices; the daily sheets will need to be turned in as well.

He also observed the restoration, or lack thereof, of the prior conditions of various roads after extensive utility work being done under the Connect America effort. One road had careful seeding performed near a house but further down the road large boulders had been left in a fencerow. Some subcontractors' work was being inspected by an engineer working for the Sprint Company. Commissioners want to follow up closely to make sure that roads are returned to their original condition.



**IN THE MATTER OF
NORTHWYE OUTER ROAD:**

A Pre-Construction Hearing for the Northwe Outer Road Grading was held at 9:00 a.m. Present were Kelly Sink-Blair, Manager, and Gary O'Day, Developer, both of MRPC; Fred Shiver, Superintendent, Sonny Kamper, Manager, and Luke Mangrum, Project Engineer, all of Bloomsdale Excavating Company; Ryan Reed, Community Development Block Grant Specialist, Missouri Department of Economic Development; and Darin Pryor, Engineer, City of Rolla. Pryor spoke about which prevailing wages would need to be paid; paperwork having been sent in to Mo DOT; possible need for a consent agreement with Mo DOT depending on the method used to measure the approximately one acre of disturbed property; the insurance coverage required; the notice to proceed letter, which will be dated October 12, 2016. Bloomsdale representatives addressed utility relocations and silt fencing. Minimizing the duration of road closure was discussed, as was the rock bid. Commissioner Hicks inquired about the estimated date of completion.

The clerk then left and further minutes were taken by Deputy Clerk Tessa Piatt.


**IN THE MATTER OF RETIREES



IN THE MATTER OF TOUGH ON TRASH:

Presiding Commissioner Verkamp said that, to his knowledge, all cattle crossings on county roads had been eliminated, and that if fences are properly maintained, livestock would never be on the county road.

The title for the 2006 Crown Victoria being transferred to the Newburg Police Department from the PCSD for consideration of \$1 was signed by Commissioner Verkamp.

IN THE MATTER OF SALES TAXES:

Treasurer Carol Green presented the October, 2016 sales taxes to the Commission. Receipts were \$240,519.65 and \$180,389.64 for County Revenue and Law Enforcement Sales Tax, respectively. These were 9.82% down and 2.92% up for the month-to-month (15/16) and the rolling twelve months comparisons, respectively.



IN THE MATTER OF
ROAD 3050:

June Dudley of 10175 County Road 3050 came to inquire if there was any assistance for replacement of driveway culverts; the Commission said no. She was in the process of having work done and her contractor planned to replace her 12 inch culvert after consulting with the Road and Bridge Department.

IN THE MATTER OF
COUNTY-WIDE SPEED LIMIT:

A hearing was held on the proposed county-wide speed limit ordinance. Present were John Buckner of the Rolla Daily News and local resident Chester Kojro. Kojro suggested 25 mph might be better on gravel though he agrees with 35 mph on paved surfaces. He inquired regarding a compilation of accident records for county roads and asked where the impulse for the speed limit ordinance originated. Commissioner Stratman said that per state law the speed limit was 50 mph unless otherwise posted and the speed limit would be a safety issue. Roads already posted, such as Old St. James Road with its speed limit of 45 mph, would be exceptions. Presiding Commissioner Verkamp said some roads already had 25 mph limits. There was a discussion regarding which roads would be affected; these would be the four-digit county roads and named roads that are within the county's road inventory. Presiding Commissioner Verkamp said there were some 330 gravel and 228 chip and seal roads, as well as 27 hot-decked roads in the county as of the last inventory, though there had been additional roads receiving hot deck surfacing since then. Road 7550, known as Mill Creek Road, had very recently received 4.1 miles of chip and seal finish under the Federal Land Access Plan grant. There being no other comments, Presiding Commissioner Verkamp closed the public hearing. Commissioner Hicks read the ordinance, whereupon Commissioner Stratman made a motion and Commissioner Hicks seconded the motion to approve the county-wide speed limit ordinance. Rolla call vote revealed Stratman-yes, Hicks-yes, Verkamp-yes.

ORDINANCE NO. 2016-10-18 (1)

AN ORDINANCE OF PHELPS COUNTY, MISSOURI, TO ESTABLISH SPEED LIMITS ON PHELPS COUNTY ROADS.

Be it resolved by the Commissioners of the County of Phelps as follows:

COUNTY-WIDE SPEED LIMIT ORDINANCE, Continued:

SECTION 1: Pursuant to RSMo Section 49.650.1, power is granted to the County Commission to adopt ordinances relating to roads controlled by the county.

SECTION 2: Speed Limits on all county roads shall be 35 miles per hour unless otherwise posted.

SECTION 3: This Ordinance shall be in full force and effect in accordance with RSMo 304.010, from and after the date of its approval by the County Commission, as indicated below.

IN THE MATTER OF
MONTHLY COURTHOUSE MEETING:

Presiding Judge 25th Circuit Bill Hickle, Treasurer Carol Green, Surveyor Lou Gilbert, Collector Davis Haas, Assessor Bill Wiggins, Recorder of Deeds Robin Kordes as well as Darin Pryor, P.E. of the City of Rolla were present. The Pledge of Allegiance was led by Presiding Commissioner Verkamp. Green gave the sales tax report, with YTD figures up 2.69%, rolling twelve month up 2.92%, but month-to-month comparison down 9.82%. Verkamp informed those attending that the 2017 health insurance premium rates were anticipated on November 17, 2016 during the meeting with Group Benefit Services. Commissioner Stratman reported a 120% loss ratio to date. With traditional major medical plans, he said, a rate increase is certain for loss ratios over 75%. Commissioner Hicks reported that all the replacement windows had been installed. Kordes spoke on the employee Christmas Party. A going-away party is planned for Health Department Director Jodi Waltman and her assistant, Ellen Fry, on December 9th. Verkamp reported on the 1972 jail rehabilitation; Stratman relayed an estimate of \$1.8 million for the renovation. The renovated jail space will not be for federal prisoners, as it will not meet standards for same, but might relieve crowding in the new jail by housing state or local inmates.

He cannot get mail from his prior state forwarded; the U.S. Postal Service says this is not a valid address. He currently is using a P.O. Box in St. James. At his request his emergency service mapping was confirmed with the E911 Dispatch Center and Phelps County Sheriff's Department, St. James Fire District, and St. James Ambulance District were found to be his responders.
