IN THE MATTER OF NORTHWYE OUTER ROAD:

Darin Pryor, P.E., of the City of Rolla came to review the explanation requested by MO DED of the bid award for aggregate. A letter was composed to the DED. Bids in general were discussed.

IN THE MATTER OF PHELPS COUNTY/ROLLA CITY COOPERATION:

Pryor reported that Rolla City was interested in having Phelps County labor to chip and seal roads, using the county's chip spreading equipment, in exchange for Phelps County purchasing reflective striping paint and the labor to apply it.

IN THE MATTER OF ROAD EQUIPMENT:

The Commission reviewed the contract for the purchase of seven new dump trucks. Five 2018 International 7500 SFA 6x4 and two 2018 International 7500 SFA 6x4 trucks came to a total of \$629,050.00 for all cabs and chassis. Additional equipment brought the grand total to \$907,834.00. Trade-in of two International, three 2011 International, and two 2013 International trucks yielded a trade-in value of \$260,811.00. IN THE MATTER OF ROAD 7530:

A discussion was held regarding the appeal of the FEMA denial of repair costs for this road. Essentially the claim had been made that the County improved the road by widening it, when the driving surface remained the same. The shoulder of this road on a very steep hill was clearly going to undergo repeated subsidence, unless significant measures were taken to augment the base of the hillside. The original project worksheet (PW) was written for the amount of \$25,795.80 and revised to \$10,422.90; actual cost for the scope of work from the original PW was \$25,609.33. The road department will request that FEMA send a site inspector to the area.

Robert Eastburn from Empower Retirement, the CERF Savings Plan, came to discuss the aspects of the plan which he felt needed more emphasis to county employees. County employees have access to four components of retirement savings: the LAGERS pension, the CERF pension, CERF savings 457 (voluntary contributions), and CERF savings 401A (the match account.) Empower has the flexibility of some self-direction, though the IRS dictates that at 70.5 years some of the funds must be withdrawn if the individual has left employment. It is taxable the year it is withdrawn; the matching amount is taxed on withdrawal; that is, contributions are pre-tax. The minimum amount required for participation is \$10 per pay period. The match percentage, 50% for the last 11 years and currently up to 6% of gross salary, is voted on yearly. He believes the Phelps County participation is about 20% of employees on the voluntary side. He also discussed the catch-up rule, managed accounts, fees, penalties.
