IN THE MATTER OF SUSTAINABLE OZARKS PARTNERSHIP:

Kent Thomas, Executive Director of the Leonard Wood Institute expressed his appreciation to Phelps County for their participation in the Sustainable Ozarks Partnership, which was incorporated into the LWI in 2012. Thomas discussed the mission of the LWI/SOP, which played an important role in the response to the Army's plan to downsize Fort Leonard Wood. He recounted the impact FLW has on the surrounding economy, with \$1,241,215,238 in annual expenditures, 26,349 direct and 39,316 total jobs, nearly \$2 billion in total wages, and an estimated total economic impact of nearly \$2.9 billion. The Base Realignment and Closure (BRAC) process impacting Fort Riley in 1995 was touched upon; Fort Leonard Wood was threatened similarly in 2005. He presented the Commission with a banner for the region being recognized as a Great American Defense Community. FLW serving as a training center for some 1200 Marines, providing DHS training, escaping closure of its hospital after some consideration were all detailed. Thomas lauded Joe Driskoll as the Missouri state military advocate. Then he requested Commissioner involvement and input, specifically participation in the August 24, 2017 meeting upcoming.

IN THE MATTER OF COUNTY HEALTH INSURANCE:

The Commission reviewed the Benefit Management Report from GBS, the third party administrator, showing loss ratio of 125%. However, the YTD Aggregate Position was \$177,204.52, reflective of capital reserves with which to meet the needs of the county employees.

IN THE MATTER OF COLLECTORS COURT ORDER:

Collector's Court Order 2016-000026, Parcel number 2016-5415.01, with removal of a sewer fee was reviewed and approved by the Commission.

IN THE MATTER OF HISTORIC BUREAU OF MINES BUILDING:

The Commission received word that the Missouri Advisory Council on Historic Preservation recommended that the Rolla Division of the Bureau of Mines Headquarters, 1300 Bishop Avenue, Rolla, be listed in the National Register of Historic Places. The nomination will be forwarded to the Keeper of the National Register and a decision is expected within 45 days thereafter.

## PHELPS COUNTY COMMISSION RECORD January 5, 2017 Second day of the January term

IN THE MATTER OF COUNTY LAND COMMISSIONER:

Dick Elgin, PE, PhD, came to discuss property in the county. In particular, an undeveloped roadbed with property owned on either side by Paul Spencer was to be deeded to Mr. Spencer. A discussion of the role of the county land commissioner ensued. Elgin stated that the land commissioner, by statute 49,280 RSMo, prepares and signs deeds on behalf of the Commission. His appointment expired 12/31/2016. The term is unspecified. He discussed a state attorney general opinion from the 1970's that the county surveyor was supposed to be paid for surveys by the county. He stated that most counties of the third and fourth class do not have elected surveyors, or at most half do. On a motion by Commissioner Stratman, seconded by Commissioner Hicks, Dick Elgin was appointed as County Land Commissioner for a four year term. Since Mr. Spencer made his initial inquiry with the Commission on 12/8/16 and his second on 12/22/16, the latter date will be used on the documents by Elgin.

IN THE MATTER OF EMPLOYEE MEAL ALLOWANCE:

The Sheriff's Department's meal reimbursement amounts were discussed. On a motion by Commissioner Hicks, seconded by Commissioner Stratman, breakfast/lunch/supper meal allowances were set at \$7.50/\$10.00/\$20.00 for county employees away on county business.

Ongoing restaurant inspections, including the cafeteria at the hospital, were discussed; Steinkamp said she inspects commercial food vendors for a charge and school cafeterias for free.

The modest increase in the home visitation contract reimbursement, the discontinuation of the Ebola grant, and the issue of increasing the Phelps County share to the health department from \$80,000 to \$90,000 annually was discussed. Plans to examine the upcoming sales tax report prior to a final decision on employee cost-ofliving adjustments were reviewed. Steinkamp stated that Core Public Health reimbursements continue a steady but gradual downward trend; Presiding Commissioner Verkamp inquired about WIC reimbursements increasing. Steinkamp said she was fairly confident that would occur. End of year cash on hand was discussed. Steinkamp discussed the pay for the current medical director; responding to a question by Commissioner Stratman, she said the medical director merely signs the standing orders written up in the Health Department annually, and providing a medical number so that Medicaid can be billed. The 2016 Health Department budget did include a three-month overlap for salaries for two positions, one the Director's, to permit training.

IN THE MATTER OF PROSECUTING ATTORNEY 2017 BUDGET HEARING:

Prosecuting Attorney Brendon Fox reviewed his 2017 budget plans; Sheriff Lisenbe attended the latter part of the discussion. Fund 460, the PA Delinquent Tax Fund, is experiencing declining revenues due to the Missouri Department of Revenue resuming collection of delinquent business taxes; the personal income tax delinquencies provide a much smaller share of the revenue. Along with Fund 480, the PA Administrative Handling Fund (for
