### **IN THE MATTER OF SINGLE SOURCE CONTRACT:**

Assessor Bill Stoltz came to discuss the single-source contract with Pictometry to provide aerial orthogonal and oblique photography for assessment and other purposes. Originally a 6-year contract specifying flights every 2 years, this will also include change detection, a system in which a polygon is drawn over every structure in the county, and alterations of the structure are detected. Phelps County Focus Staff Writer Andrew Sheeley was also present. Stoltz estimates a cost of approximately \$288,000 over a new 6-year agreement. Commissioner Stratman inquired about other political subdivisions contributing if they benefit from the technology; Stoltz said that Rolla did some cost sharing, but otherwise no others did. On a motion by Commissioner Hicks, seconded by Commissioner Stratman, the following advertisement was approved:

**IN THE MATTER OF  
COUNTY PROPERTY AT  
204 FAIRGROUNDS ROAD:**

As of 0915, the scheduled bid opening time, no bids had been received. Commissioner Stratman said that this would mean that the County would be allowed to negotiate; the 2010 appraisal and potential zoning were discussed.

**IN THE MATTER OF  
PCSD GRANTS:**

Corporal Mike Kirn of the PCSD came to discuss renewal of a grant from Mo DOT for Speeding Enforcement; this is a federal pass-through grant of \$5,000 annually. On a motion by Commissioner Stratman, seconded by Commissioner Hicks, this was approved.

**IN THE MATTER OF  
EMERGENCY MANAGEMENT  
DIRECTOR AND MASS CASUALTIES:**

EMD Kirn then discussed mass casualty events and their challenges, since so many of the County resources are located in the city of Rolla with little redundancy in the County.

**IN THE MATTER OF  
FEDERAL SINGLE AUDIT:**

The sole bid received as of 1000 for Federal Single Audit services was opened; for 2015 and 2016, Stopp & Van Hoy of Creve Coeur bid \$20,000. This was taken under advisement.

**IN THE MATTER OF  
COURT ORDERS:**

Court Order Certificate number 2017002620, Account number 2014-49869 for Personal Property, was reviewed. This was within the Tax Code of R1-ST-ST-ST (St. James School, St. James City, St. James Fire and Ambulance); the value had been deleted by mistake and was restored from "0" to \$9030. This was approved on a motion by Commissioner Hicks, seconded by Commissioner Stratman.

**IN THE MATTER OF  
DOCUMENT DESTRUCTION  
AND SHREDDING SERVICES:**

Local vendor Jim Standfast with A-1 Document Storage and Shredding came to offer his company's services to the County, mentioning the consternation caused when an out-of-town shredding vendor (Shred-It) was seen at the Courthouse. The clerk informed him that for the years 2015, 2016, and 2017 the payments to Shred-It had been \$481, \$651, and \$559; those to A-1 Document had been \$4,756, \$4,732, and \$4,661, respectively.

### IN THE MATTER OF CITIZEN INPUT:

Local resident George Eckhardt came to draw attention to heavy masonry mailboxes which are put within the County right-of-Way, or within a foot or two, and stated he thought they were a hazard. Commissioner Hicks said that the liability would be that of the homeowner. Eckhardt also offered the opinion that the Phelps County Courthouse should have a metal detector.

### IN THE MATTER OF ACCOUNTS PAYABLE:

Payment of 14 invoices in the amount of \$162,647.80 for payroll cycle garnishments and deductions and \$74,710.97 in general and contract pay invoices was reviewed and approved.

### IN THE MATTER OF JUVENILE PERSONNEL:

The clerk reported that effective February 28, 2018 the Juvenile Office Attorney had resigned, and he would revert back to his existing contract with the Juvenile Office for monthly pay.

### IN THE MATTER OF CLOSED SESSION:

With the late arrival of an individual wishing to submit a bid for the 204 Fairgrounds Road property, the Commission elected to enter closed session pursuant to RSMo 610.021(2) on a motion by Commissioner Stratman, seconded by Commissioner Hicks, at 11:35. Having taken no actions, the Commissioner returned to open session on a motion by Commissioner Hicks, seconded by Commissioner Stratman, at 11:38.

### **IN THE MATTER OF MASS NOTIFICATION SYSTEM EVERBRIDGE:**

The Commission received notice that Rolla Municipal Utilities elected not to participate in sharing the expense of Everbridge, as they did not utilize it. Phelps County Focus Staff Writer Andrew Sheeley was also present.

### **IN THE MATTER OF FEDERAL SINGLE AUDIT:**

On a motion by Commissioner Hicks, seconded by Commissioner Stratman, the offer for 2015 and 2016 federal single audit services from Stopp and Van Hoy, Creve Coeur, costing \$20,000, was accepted.

### **IN THE MATTER OF PHELPS COUNTY EMERGENCY SERVICES BOARD:**

The Commission reviewed the March 2018 PCESB Treasurer's report.

### **IN THE MATTER OF COLLECTOR'S COURT ORDER:**

Personal Property Court Order numbered 2017002647, restoring a late assessment penalty (LAP) to an account which had been erroneously dropped from the tax books despite having been paid, was approved on a motion by Commissioner Stratman, seconded by Commissioner Hicks.

### **IN THE MATTER OF 1972 JAIL RENOVATION:**

Sheriff Rick Lisenbe attended to discuss this project.

### **IN THE MATTER OF FEDERAL PRISONER BOARD:**

The Sheriff also reported on potential increased per day payments for federal prisoners; if an increase materializes the transport reimbursement requests may be waived or reduced by PCSD. Responding to a question from Commissioner Hicks, Lisenbe said it was hard to estimate the average incarceration time for a state offender. The spectrum of charges faced by the jail prisoners was discussed; some are convicted and are awaiting a Department of Corrections transfer.



### **IN THE MATTER OF FLOODPLAIN BUY-OUT:**







### **IN THE MATTER OF BEAVER MANOR ROAD:**

Don and Peggy Isgrigg came to address the Commission. Phelps County Focus Staff Writer Andrew Sheeley and Michelle Bock of the Special Road and Bridge Department were also present. The Isgriggs were inquiring on behalf of their daughter, Cindy Mitchell, who owns land beyond the last two lots on either side of the paved segment of Beaver Manor. The Isgriggs' and their daughter believe that a culvert just beyond the end of the paved surface of the road is undersized and significantly impeding the drainage toward Beaver Creek just feet away. The Isgriggs would like to purchase a properly-scaled culvert for the situation and have the Road Department install it. The Commission referred them to Superintendent of Roads Walter Snelson to coordinate this. Beaver Manor was accepted as a road in 1971.

### **IN THE MATTER OF FIRE DISTRICT BOARD TRAINING:**

Paul D. Smith came to inquire about training for board members.

### **IN THE MATTER OF SALES TAX:**

Treasurer Carol Green presented Phelps County sales tax figures for March, 2018. County tax and Law Enforcement Sales Tax were \$272,027.07 and \$204,060.47, respectively. These were up over 13% as compared with one year prior but the rolling twelve month comparison showed an increase of just 0.11%.

### **IN THE MATTER OF JUVENILE VEHICLE:**

Presiding Commissioner Verkamp called Chief Juvenile Officer Andy Helm to inquire about a car they wished to replace; Helm said their 2007 Ford Taurus would be kept and not traded.

### **IN THE MATTER OF PRESCRIPTION DRUG MONITORING PROGRAM:**

Retired Rolla Police Detective Paul Rueff came to speak to the Commission about what he felt to be the extreme need for a prescription drug monitoring program (PDMP). He said that with the sharp increase in opioid overdoses in the county, some fatal, that Phelps County needed to follow the example of the remaining 49 states and institute a PDMP as soon as possible.

### **IN THE MATTER OF CYBERSECURITY GRANT:**

Detective (James) Scott Jarrett presented renewal paperwork for the 2019 Phelps County Cyber Task Force grant. The State Cyber Crime Grant is purely state money through the Missouri Department of Public Safety, funding South Central Missouri Computer Crime Task Force (SCMCCTF) which encompasses a nine county area: Phelps, Dent, Crawford, Texas, Shannon, Reynolds, Iron, Washington and Pulaski Counties. These grant funds will be used to continue to provide a source of technology expertise to assist law enforcement in South Central Missouri in investigation and prosecution of cases where digital evidence may be involved, particularly in crimes against children. The services are to include forensic examinations of digital media, support for search warrant executions, proactive peer to peer investigations, school and public internet safety presentations, and investigation of CyberTips in the region. On a motion by Commissioner Stratman, seconded by Commissioner Hicks, this was approved.

### **IN THE MATTER OF CITIZEN INPUT:**

Local resident Ray Schweikhardt asked why the local paper should have a large article about gun deaths when in 2017 there were 28 drug deaths in the County and only 2 gun deaths. He also asked if the number of doses dispensed over the past year in the County is public information.

### **IN THE MATTER OF HEALTH DEPARTMENT NALOXONE ADMINISTRATION:**

Phelps/Maries Health Department Director Ashley Wann discussed a standing order from Randall W. Williams, M.D., Director of the Missouri Department of Health and Senior Services, allowing for administration of 2 mg. dose of nasal naloxone (Narcan © ) without a local physician prescription. Wann then proposed the health department becoming an approved naloxone distribution center, distributing only to first responders who showed proof of training in its use. Commissioner Stratman queried whether the hospital would not be shouldering liability for this already, and asked her to discuss with personnel at PCRM, partly to avoid duplication. Schweikhardt asked about cost and shelf-life; Wann said that each dose had a shelf life of a year and cost \$125. Wann will look into this for Maries County.

Commissioner Hicks then referred to county-based prescription drug monitoring programs, or PDMP's. Wann said the meeting in St. James concerning opioid abuse revealed a good deal of support for the PDMP; she said some counties are joining St. Louis County's PDMP. Presiding Commissioner Verkamp felt the PDMP needed to be put on the fast track, as did Commissioner Stratman.

Local resident Lowell Davis visited with the Commission about the deterioration of the margins of this road; Superintendent of Roads Walter Snelson will be notified.

IN THE MATTER OF  
MEDICAL RESERVE CORPS:

Commissioner Hicks made a motion, seconded by Commissioner Stratman, to authorize Phelps/Maries Health Department Director Ashley Wann to activate the Medical Reserve Corps should the need arise due to a disaster in Region I. Volunteers in this circumstance would be covered under Health Department liability and worker's compensation.

IN THE MATTER OF  
COUNTY HEALTH OFFICIAL:

Pursuant to RSMo 205.100, on a motion by Commissioner Stratman seconded by Commissioner Hicks, Wann was also appointed County Health Official, with the power of quarantine, among others.

IN THE MATTER OF  
BICYCLE LANES AT ROLLA WEST:

Local resident Chester Kojro, an avid and frequent cyclist, shared his concerns about the arrangement of the bike and vehicular traffic lanes near the intersection of the north outer road and Road 8110/Sally Road. He believes them to be unsafe.



### **IN THE MATTER OF GRANDVIEW ESTATES:**

William Bicknell of Stoney Ridge Court spoke with the Commission about paving the roads in the Grandview Estates subdivision. Rolla Daily News Writer Lori Amos and Phelps County Focus Staff Writer Andrew Sheeley were also present. Bicknell reminded the Commission of its September 27, 2016 grant of a variance for road width from 24 down to 22 feet of width, providing all other specifications were met, for inclusion in the county's road inventory. Bicknell wanted to review four items specified in the June 1, 2007 ordinance governing subdivision roadway acceptance for county maintenance. Item one relates to a plat showing the location of all utility systems within the subdivision being provided to the county. Bicknell said there were no gas lines; no sewer lines as the subdivision's lots are served by their own septic systems; electric power lines are overhead to each electric box on a given lot and then buried en route to each residence. He stated he had but one existing drawing showing utility locations, and questioned whether this was sufficient. The second item was a storm water drainage plan as identified in the Phelps County Road Specifications. Bicknell said there was "no plan" available from the original engineering firm, though he said that while residing there for 10 years only one occurrence of a water problem existed, and that was at the intersection of Sterling Hills Drive at the ditch along County Road 4000. He stated that as long as he personally would keep the ditch clear, there was no trouble.

The third item was certification by a registered professional engineer provided to the County that all roadway structures, drainage structures, and utility systems have been constructed in compliance with the Phelps County Regulations and Specifications for each respective item. In September 2017, Superintendent of Roads Walter Snelson had said that the base of the road was adequate. Item 4 encompassed County Highway roadways in the subdivision being accepted. Bicknell asked whether the County would accept the subdivision roadways if they were properly surfaced with 2 to 4 inches of asphalt. He had obtained two quotes for this, on Sterling Hills Drive and Stoney Ridge Court. Bicknell had an estimate of the cost to each property owner. Commissioner Hicks said he felt that confirmation of the adequacy of the road substrate would be necessary. Presiding Commissioner Verkamp asked if a letter of concurrence from the Commission would bring a few remaining property owners into agreement. Commissioner Hicks asked about the diameter of the cul-de-sacs; Bicknell said they were 85 feet in diameter, while the County stipulated 80 feet.

The Commission reviewed and approved payment of 49 invoices in the amount of \$36,203.59.



### **IN THE MATTER OF MEDICAL TRANSPORT:**

Andrew Zink and Stephanie McCormick from MASA Medical Transport Solutions presented the services their firm provides. Rolla Daily News Reporter Lori Amos was also present. It was the first prepaid air ambulance service in the country, based in Fort Lauderdale, FL. Zink said they had 1.25 million members, and 80 of the approximately 550 Missouri school districts. He said they provide service to Texas County and Rolla Public Schools. Three levels of service were discussed; all but the highest priced are offered only through employers who offer insurance to their employees. The company is basically a second insurer. The benefit is post-tax only, and the county would be asked to arrange payroll deduction or payment as an employer benefit.

### **IN THE MATTER OF ROAD 5180:**

Presiding Commissioner reported on the area Mo DOT engineer, Preston Kramer, letting him know that material would be supplied if the county would craft an improved entrance onto Highway 63.

### **IN THE MATTER OF HEALTH DEPARTMENT NALOXONE ADMINISTRATION:**

Phelps/Maries Health Department Director Ashley Wann came to provide an update on the possibility of her department providing naloxone to first responders. She said that after a newspaper report, there was some protest that taxpayers would be purchasing this; she refutes that contention, as it is supplied by the state. She believes they will have grant funding for it, and plans to use the standing order from Dr. Randall Williams, Director of MO DHSS.
