IN THE MATTER OF RECORDER OF DEEDS EQUIPMENT CONTRACT:

Phelps County Recorder of Deeds Robyn Kordes and Brian Sexton, with Missouri Document Solutions of Ozark, presented a single-source bid for ST imaging microfilm scanner. Kordes uses this equipment as a back-up when the internet is down; she cannot read what her current equipment generates. Local resident Ray Schweikhardt and Andrew Sheeley, Staff Writer for the Phelps County Focus, were also present. Despite advertisement, only one bid was received. The equipment bid was \$7,000.00 with an additional \$700.00 for a one-year service agreement, which is renewable. This equipment is not on the state bid; the expense will come from the Recorder's User Fee Fund. This was approved on a motion by Commissioner Stratman, seconded by Commissioner Hicks.

IN THE MATTER OF SALES TAXES:

Phelps County Treasurer Carol Green came to report sales tax receipts for the month. County 0.5% sales tax and Law Enforcement Sales Tax 0.375% amounts were \$273,627.88 and \$205,220.74, respectively. These were up 24.17% from the same time in 2017, but the cumulative increase was 0.64%, with 3.91% increase shown in the rolling twelve month comparison. Use Tax and Internet Sales Tax were discussed.

IN THE MATTER OF RESTAURANT INSPECTIONS:

Phelps/Maries Health Department Director Ashley Wann and Sanitarian John Campbell attended to speak about a local restaurant whose food service permit was suspended for three weeks. Bare-hand contact with cooked food was the primary issue. The owner had earlier been provided with the City of Rolla food code. A meeting with Missouri Department of Health and Senior Services, the Rolla City Code Inspector, Wann, the Phelps County Prosecuting Attorney, and the owner is planned.

IN THE MATTER OF HEALTH DEPARTMENT CONTRACT:

A mini-grant from the Children's Trust Fund of \$3,842, which will cover some employee training for childhood abuse and neglect, was approved on a motion by Commissioner Hicks, seconded by Commissioner Stratman.

Phelps County Superintendent of Roads Walter Snelson, Michelle Bock of the Road Department, and Jared Hutsell with Van Keppel, a dealer for Entyre equipment, arrived. A new chipper will cost \$350,000.00, with \$3,000 annually for two extra years of warranty coverage. Local resident Chester Kojro also attended. Commissioner Stratman expressed concern about the obsolescence of, and the inability to repair, the current chip and seal equipment. Hutsell said the Entyre company has a good track record of repairing such equipment as far back as the 80's. Lease options and rental rates were discussed: \$57,410.40 per year for 5 years; \$76,047.60 per year for 3 years; rental for \$15,000/month for three months. A rental purchase agreement is three months' rent with Van Kippel retaining 20% of each month's rent, with 80% of that rent (\$36,000 over three months) going toward purchase. Hutsell said he could guarantee a build date of July 23, 2018; their hauling/delivery is done by a trucking firm from Springfield. Presiding Commissioner Verkamp asked Hutsell to verify the state bid.

IN THE MATTER OF ACCOUNTS PAYABLE:

The commission reviewed and approved payment of 70 invoices for a total of \$74,734.61.

IN THE MATTER OF PAYROLL:

Rolla Daily News Reporter Lori Amos was The letter contained responses to document also present. justification supporting the county's position that the project qualified; specified the monetary figure in dispute as \$44,286.50 reimbursed to the county for total eligible cost of \$65,456.62; provisions in federal law believed to be inconsistent with initial action were expounded upon in considerable detail. The County had not been informed of any alternate repair options until after the work was complete. repair was urgent if not emergent since emergency personnel were using an alternate route which added 45 minutes to response time. The County requested that FEMA's determination that the County should repay the reimbursement on the repair, dated May 14, 2018, be reversed.

The Commission discussed dust raised by traffic on this road.

IN THE MATTER OF ROAD EQUIPMENT:

Delivery of the new oil distributor truck was discussed.
