IN THE MATTER OF SALES TAXES:

Local resident Ray Schweikhardt was present; Treasurer Carol Green entered to report on the sales tax receipts for May, 2021. The 0.5% county sales tax revenue was \$249,668.07, an increase of 9.78% in the month-to-month comparison and up 5.46% in the rolling 12-month view.

IN THE MATTER OF AMERICAN RESCUE PLAN ACT (ARPA) FUNDS:

Green reported that she encountered a process on the U.S. Treasury's website which required her to supply a copy of her passport and driver's license as she tried to register the county as an ARPA recipient. She contacted MRPC to ask them why this was necessary. The Zoom meeting discussing the use of these funds, with MRPC leadership, is rescheduled. Commissioner Auxier mentioned infrastructure improvements that may not be funded when the stimulus funds disappear. Green left at 0912 and returned a few moments later to report that she had a roughly 150-page Treasury Interim Rule pertaining to ARPA, with highlighting of the segments applicable to counties.

IN THE MATTER OF BRO-B081(13) ROAD 7100:

The Commission reviewed Progress Invoice #18 for this federal bridge project, consisting of \$121,149.60 in construction costs due to Gene Haile Construction. As moved by Commissioner Hicks and seconded by Commissioner Auxier this was approved for payment as well as reimbursement submission to MoDOT. A forthcoming change order Number 2 will pertain to the bridge's east end where an additional 8 feet of pavement work will be needed to accommodate proper expansion joints being installed.

IN THE MATTER OF .
MISSOUR DEPARTMENT OF CONSERVATION (MDC) CART FUND AMENDMENT:

Doolittle's mayor told Commissioner Hicks that the city just could not maintain Old 66 through Doolittle; the feeling is that MoDOT may need to take over the portion of 7100 when the bridge is finished, as it is an emergency bypass route, and perhaps take in the segment in Doolittle as well. Collector Faith Barnes entered at 0950.

IN THE MATTER OF SENIOR COMPANIONS 45<sup>TH</sup> ANNIVERSARY RECOGNITION:

Leuthauser said she would have 54 recognition certificates for her Senior Companions and spoke about the gift certificates and recognition she and her staff planned for the companions.

IN THE MATTER OF PAYROLL:

IN THE MATTER OF GAS TAX LEGISLATION:

Passage of the gas tax legislation was discussed. The county's percentage will be the same but of a larger base amount, of course, with 12.5% added to the current 17% tax on gasoline by the time five years elapse and the entire increase is in effect.

IN THE MATTER OF INFRASTRUCTURE BILL AND HIGHWAY 63 IMPROVEMENT:

Federal legislation is currently in process for infrastructure funding. The Commissioners discussed whether or not any improvements to Highway 63 would be included. Cole County had "bailed" on being involved, and Commissioner Auxier was planning on attending a meeting on the Highway 63 issue and said he would focus on listening to everyone's opinions and input.

IN THE MATTER OF THE MISSION:

Commissioner Verkamp said that the director of The Mission made inquiry about funds dedicated to the homeless in the ARPA; he would prefer that she present her case to the Commission as a whole. Local resident Chester Crider entered at 0920 and visited briefly, then left about 0930.

IN THE MATTER OF BRO-B081(13) ROAD 7100:

The progress on the bridge was discussed. Construction may need an extension until June 10; the Great Race comes through on June 12.

Treasurer Carol Green entered and reported on recent legislation. She had been to Jefferson City for the MAC board meeting. The "Wayfair" bill addressing internet sales taxes, increased payments for both Assessor's per-parcel and prisoner per diem rates, and the gas tax were all subjects covered.

IN THE MATTER OF AMERICAN RESCUE PLAN ACT (ARPA):

Green relayed concerns about the process of becoming authorized, and certified, to apply for ARPA funds for the county. The mechanism set up by the U.S. Treasury requires an authorized representative who must submit two primary forms of ID and two secondary forms of ID; certification will require an individual to have a webcam on their work computer and facial recognition will be employed. Additionally, a conflict-of-interest policy meeting federal guidelines, not just state guidelines such as the policy already in effect for Phelps County, will be needed. Commissioner Hicks asked if there was a deadline for submittal of this information; the answer is unclear.

IN THE MATTER OF BID OPENING AND AWARD, FRESH-AIRE UV PURIFIERS AND REPLACEMENT LAMPS:

Bids were opened as scheduled at 1000. The bids were as followed:

IN THE MATTER OF CENTURYLINK:

Superintendent of Roads Walter Snelson, Michelle Bock of the Road Department and Phelps County Focus Staff Writer Andrew Sheeley were present for a discussion of the prospect of utility work along Road 3410. There is little shoulder allowance for any buried line according to Snelson, and in his opinion the contractor(s) should be bonded against the risk of damage to county roadways. Snelson said, "Everybody's fences are right on the road" and that left little or no room for proper ditches. Chris Mueller with CenturyLink entered at 0915; he began by saying the company wanted to bury internet cable along Roads 3410 and 1050 [Republican Road]. Mueller said they previously laid fiber in the St. James area to meet CAF (Connect America Fund) requirements. The company assessed the number of living units potentially to be served for Roads 3410, 1050 and State Routes F and NN. Mueller said the CAF program was a 5-year program and is ending as it one year over. Responding to a query by Commissioner Hicks, Mueller gave some information on delivery of fiberoptic to the end-user and gave some particulars of how this is done. Topography forces CenturyLink to be "copper the last mile" as wireless will not work. Commissioner Hicks asked if CenturyLink planned to approach Phelps County for ARPA funding for their project; Mueller did not believe so. Local resident Chester Kojro entered at 0925. Presiding Commissioner Verkamp thanked Mueller for the information; subsequently a discussion ensued of many details of the company's potential work in the county; Commissioner Hicks mentioned that the County had experienced significant concerns in the past with work that compromised road integrity. Commissioner Auxier suggested that a bond would be advisable and that if Snelson said that damage repair would cost a certain amount, the contractor would be liable for that much. This was followed by mentions of the complaint process; specifications for line depth and placement; the anticipated location of the lines to be set with plans for aerial line along the John Smallwood property on Road 3410 due to impenetrable rock there, with lines buried again south of the Dry Fork nearly to Highway F, line probably crossing to a pedestal just north of the junction of Road 3520 with 3410. Mueller said he could be contacted with any and all concerns and he provided his contact information; he would obtain the bond number from Schatz Underground for the County. Collector Faith Barnes entered at 0930. There have been numerous requests for high-speed internet along Roads 3410 and 1050. Mueller additionally acknowledged that tree removal, even in the County right-of-way, was often a very sensitive issue. Barnes left at 1000. Snelson said that Road 2340 [Craig Road] was a "total disaster" for a year after Schatz or perhaps one of their subcontractors did some trench work. When asked by Commissioner Auxier, Mueller said he would

make sure all trucks, equipment and worksites would be marked with company names in compliance with RSMo 290.290.

IN THE MATTER OF ROADS:

The Commissioners discussed the extremely large culvert put in along road 3610 and some other road matters. Sheeley left at 1020.

IN THE MATTER OF AMERICAN RESCUE PLAN ACT {ARPA}:

Treasurer Carol Green entered at 1020 reporting that she may have successfully negotiated the registration/certification for ARPA. She is in a review status of some kind. She and Kojro left at 1050.

IN THE MATTER OF ROAD 7050 BRIDGE:

Commissioner Hicks reported an incident days before wherein a truckdriver northbound from the dogfood plant on Road 7000 realized the road was closed ahead for the construction of the bridge at 7000 and 7100; he attempted to back his truck onto the bridge. Both the truck and the load were lost over the bridge but the damage to the curb on the bridge is not structural, according to MoDOT. Commissioner Hicks said a sign warning against tractor-trailer traffic past the dogfood plant is going to be installed. Presiding Commissioner Verkamp voiced his disappointment that there will be no left turn of such vehicles from northbound Road 7000 to westbound Road 7100 when the federal bridge project is completed.

IN THE MATTER OF COLLECTOR:

Collector Faith Barnes returned at 1100 to discuss a range of subjects including speeding on Road 8010, an Elected Official/Department Heads meeting and whether there is a 5-year or a 10-year plan for the county. Commissioner Hicks mentioned the proactive nature of the agreement on the Westside TIF and the TDD; now with the unexpected stimulus money being provided in spite of massive amounts of federal debt, which could not have been planned for, long-range forecasts are not stable. Barnes mentioned as she left that there was a five-year plan for the city of Rolla.

Management of drainage in the area with payment to the County Treasurer were briefly discussed; Klossner left at 0910.

IN THE MATTER OF PCSD:

Sheriff Mike Kirn entered at 0910. Numerous topics were discussed including demolition of properties purchased on W. 2nd Street; the new shooting range on Road 3410 which Presiding Commissioner Verkamp said should be included in the expansion of fiber by CenturyLink;, use of the 1972 Jail; CCW classes; voluntary immunization of approximately 50 members of the jail population against COVID-19 being started; a recent man in his 30's found dead in Mill Creek from overdose, intoxication, drowning or some combination; Rainbow People using the area but largely being peaceful and following the rules; medical cannabis issues; hiring jailers; federal prisoner census; chip shortage impeding the installation of HomeWAV kiosks for phone and mail in the new jail. Kirn left at 0940.

IN THE MATTER OF BRO-B081(13):

Commissioner Hicks presented change order #2 which was a no-cost change order extending the date of the completion to June 10; he believes this will be easily met. Commissioner Hicks moved and Commissioner Auxier seconded approval of Change Order #2. The Merchant's Bonding form was also completed.

IN THE MATTER OF CENTURYLINK:

In the judgement of the Road Department, a \$500,000 bond would be required for the work of CenturyLink and any subcontractors as they installed fiber along Roads 3410 and 1050. Commissioner Auxier wondered if twice that much wouldn't be advisable; the Commission briefly considered an average of the two but settled on \$500,000. Presiding Commissioner Verkamp notified the Road Department by phone. Sheeley left at 1000.

District 1 Commissioner Joseph H. Auxier was absent. Deputy Clerk Lisa Dowdy took minutes in the clerk's absence.

IN THE MATTER OF DOOLITTLE RURAL FIRE PROTECTION DISTRICT:

Captain Bryan Stevenson and Fire Chief Brandon Williams of the district attended. Local residents Ray Schweikhardt and Chester Kojro as well as Phelps County Focus Staff Writer Andrew Sheeley and Collector Faith Barnes were also present. Williams reported that the district responds to 20-25 cardiac arrests annually and would like to request American Rescue Plan Act (ARPA) funds to purchase automated external chest compression equipment; their total annual budget is approximately \$65,000. Stryker Medical sales representative Christina Elias provided a demonstration of the equipment, showing how the device is said to limit aerosol exposure, move with the patient and is supplied with a 45-minute battery. This would cost \$18,991.80 including a service agreement, reduced to \$18,600.80 should DRFPD elect to purchase only one external power supply attachment. Presiding Commissioner Verkamp recommended first applying for CARES Act funds; ARPA could be used if the former were exhausted.

IN THE MATTER OF SALE OF PCSD BOAT:

Doolittle Rural Fire Protection District Board President Paul Smith presented some documents for the Commission to sign to permit transfer of the boat from PCSD to the district. As moved by Commissioner Hicks and seconded by Presiding Commissioner Verkamp, the documents were approved.

IN THE MATTER OF SALES PRESENTATION:

Kevin Anthony of Scotwood Industries presented information about a product for dust control on the roads. He offered a ¾ mile demo if several other counties could be included. Anthony maintains that the silica dust from limestone roads can be controlled for about \$1.00 per foot with their product, delivered by tanker from St. Louis. Currently Boone and Lincoln counties are using the product. Commissioner Hicks pointed out that the County did not have a means of storage for the product; Anthony said they usually both deliver and apply with a tanker.

IN THE MATTER OF PUBLIC ADMINISTRATOR:

Public Administrator Dana Sooter entered to inquire about payment of an invoice for updating her page on the county website. She also reported that she had billed one ISL for

approximately \$32,000.00 in fees. Between 2014 and 2018, Missouri's state budget 22% to accommodate 5,194 ISL clients, who between late 2017 and 2018 cost, on average, over \$103,000 per year.

IN THE MATTER OF UNIVERSITY OF MISSOURI EXTENSION:

University of Missouri Extension Community Engagement Specialist Rachel Buenemann and Extension Council Chair Maretta Diestlekamp entered with the request that the sole County employee in their office have the same accrued leave policy as the other general employees of the County. They were assured that this had already been instituted. Buenemann also was able to report that the Extension Council had received a Health Options Grant that was to be used to provide Food Safety certification in one of the Rolla City parks.

IN THE MATTER OF ACCOUNTS PAYABLE:

The Commissioners reviewed and approved lessening a recent A/P batch recently paid from \$119,423.74 to \$119,324.65 for sales tax of \$99.09 that was not paid on an item.

IN THE MATTER OF PAYROLL:

The Commissioners reviewed and approved payroll for May 28, 2021 representing work dates of 5/1-15/21.

IN THE MATTER OF RIGHT-OF-WAY WORK AND BONDING REQUIREMENTS:

Schatz Underground, Inc. of Villa Ridge, MO is to be a subcontractor for CenturyLink in their installation of more service lines in the Phelps County right-of-way. Pursuant to an earlier discussion about bonding requirements, the Commissioners recommended a bond amount of \$50,000 as moved by Commissioner Hicks, seconded by Presiding Commissioner Verkamp.

Now at this the 27th day of May 2021 the Commission met pursuant to adjournment and a quorum was present of the following members:

District 1 Commissioner Joseph H. Auxier was absent.

IN THE MATTER OF HOSPITAL PROPERTY:

Hospital property in Cuba was to be sold; though the listing had been amended from over \$100,000 to just over \$90,000, the hospital had been offered \$30,000. After speaking with the broker, it was learned that broken pipes in the structure had caused damage so the value was greatly lessened. Local resident Ray Schweikhardt and Phelps County Focus Staff Writer Andrew Sheeley were also present. Sheriff Mike Kirn entered at 0920.

IN THE MATTER OF SHERIFF'S DEPARTMENT.

Sheriff Kirn reported there was an in-custody death overnight at the jail; an autopsy is pending. The state will be handling the investigation. This was a federal inmate who had been in custody for 90 days. Kirn thinks drug overdose must be ruled out; extensive modification to processes and procedures have been necessary to combat the inmates who at first concealed drugs in body cavities. Once body scans were done and cavitation of contraband was no longer feasible, inmates began to employ paper mail which was soaked with drug solutions, dried, and chewed by inmates resulting in intoxication. Most mail is scanned and presented to inmates virtually; an exception was made for legal mail from inmate counsel on the advice of federal law enforcement. With this incident, however, Kirn said they will copy legal mail and shred the originals. Michelle Bock of the Road Department entered at 0940. Paper can be soaked with methamphetamine, fentanyl or heroin. Kirn said the networking of payments to inmate accounts, or "books" for commissary is quite elaborate and there may be considerable numbers of inmates receiving money from the same individual. Commissioner Hicks asked about the position of the Sheriff's Association and wondered if the amount of money on an inmates account perhaps could be capped. Sheriff Kirn left at 0950.

IN THE MATTER OF ROADS:

Presiding Commissioner Verkamp said he "has every confidence that SRB will be able to fix" the weakened area on Road 8050, where a landowner has paid for chip and seal. Several culvert installations were discussed. Bock asked for guidance on what residents should understand about right-of-way widths. Local resident Bob Wilson on Road 6130 at the intersection with Highway T has had some issues with semi-trucks turning around because his driveway makes a loop with the road; he may look into building a fence but wanted to observe County regulations. Bonding requirement for Schatz Underground was discussed; Bock

had reservations at the reduction to \$50,000. Water on Old 63 was mentioned. Sheeley left at 1000 and Schweikhardt left at 1010. Bock expressed the hope that there would be a return to a rotating schedule of roads maintenance, such as the 1000's one year, and so on. Priorities, frequencies and reasonable expectations were discussed, with reference to MoDOT's approach.

IN THE MATTER OF CART FUNDS:

Treasurer Carol Green entered at 1035 and reported CART Gas Tax revenue was \$53,354.36 for April, 2021. This was an increase of 8.09% in the month-to-month comparison. Motor Vehicle Sales Tax was \$26,0007.59, 54% of the annual budgeted amount. Motor Vehicle Fees were \$10,800.82, 40% of the budgeted yearly total. The surge in gas tax was noted but also a very large increase for the second month in a row for MV Sales Tax and MV Fees. She left at 1055.

IN THE MATTER OF CORONER:

Coroner Ernie Coverdell entered at 1100 to report that he logged 110 hours in about 9 days; he is 9 reports under and awoke at 5 a.m. to catch up but was called in to PCSD for the death in the jail. Pending legislation making the coroner's position FT and coroner pay was discussed.

IN THE MATTER OF CLOSED SESSION:

Commissioner Hicks moved and Presiding Commissioner Verkamp seconded entering closed session at 1125 pursuant to RSMo 610.021 (17) - auditor work product. Collector Faith Barnes was also present. No actions having been taken, the meeting returned to open session as moved by Commissioner Hicks and seconded by Presiding Commissioner Verkamp at 1133.

IN THE MATTER OF ACCOUNTS PAYABLE:

The Commissioners reviewed and approved payment of 56 and 44 invoices in the amounts of \$79,975.84 and \$71,991.71, respectively, and \$3,158.74 for grand juror pay.
