IN THE MATTER OF ELECTED OFFICIALS AND DEPARTMENT HEADS MEETING:

Present were Assessor Bill Stoltz, Coroner Andy Davis, Collector Faith Barnes, Treasurer Carol Green, University of Missouri Extension Engagement Specialist Rachel Buenemann, Phelps/Maries Health Department Director Ashley Wann, Sissy Korich of the Building and Grounds Department, Senior Companions Director Yvonne Leuthauser, Sheriff Rick Lisenbe, Public Administrator Kathy Oliver, local residents Kristina Leininger, Joey Auxier, and Tom Reed and Phelps County Focus Staff Writer Andrew Sheeley. Because of the number of attendees and the desire for social distancing due to the COVID-19 situation, the meeting relocated to the multipurpose room. Lisenbe left. Subsequently office holders and department heads introduced themselves, gave a synopsis of the role in county government played by their office, and when prompted by Barnes reported on how their operation(s) had been changed by COVID-1. Buenemann and Barnes reported having mission statements. The meeting then dismissed to the commissioners' hearing room and all left but Davis, Wann, and Green.

IN THE MATTER OF COUNTY CORONER:

Davis provided information on some changes, statewide, to the organization of coroner's offices. There is a commission under the Department of Health and Senior Services (DHSS) comprised of funeral directors, sheriffs and some medical examiners which will be reviewing and revising the coroner's training programs. The Sheriff's Association, he said, did not want this commission within the Department of Public Safety, instead wanting it within DHSS. Davis said deaths attributable to opioid misuse were stable to increased.

IN THE MATTER OF BID OPENING AND AWARD, CERTIFICATES OF DEPOSIT:

Treasurer Carol Green was in attendance as bids for Certificates of Deposit were opened as scheduled at 10:00 a.m. The following amounts were being bid: Meramec Home Health Association (MHHA) monies, \$225,000; Unemployment Fund, \$100,000; Law Enforcement Debt Service Fund, \$200,000; PA Drug Fund, \$125,000 which was a reduction from prior year \$150,000; Public Facilities or Courthouse Sales Tax Fund, \$500,000; Jay White Fund \$200,000; Law Enforcement Sales Tax Fund, \$3,000,000. Six and 12-month APY interest rates were requested.

As moved by Commissioner Hicks and seconded by Commissioner Stratman, checks would be requisitioned so that the funds could be transferred the next day.

IN THE MATTER OF SALES TAXES:

Green provided the sales tax report for July, 2020 which showed county 0.5% sales tax receipts of \$259,039.72 and law enforcement 0.375% sales tax receipts of \$194,279.41. These amounts were 70 2.53% in the month-to-month, up 0.61% in the YTD and up 3.41% in the rolling twelve-month comparisons, respectively.

IN THE MATTER OF ROAD 2170:

Michelle Bock of the Road and Bridge Department arrived and the replacement of the metal culvert with a concrete box culvert under this road was discussed. The Phelps County Landfill Board was willing to entertain not only payment for the culvert, but blacktop of the road for a length of approximately 1/3 of a mile; this segment is heavily used by loaded trucks.

IN THE MATTER OF FUEL BID AWARD, ROAD AND BRIDGE:

As moved by Commissioner Stratman, seconded by Commissioner Hicks, the fuel bid was awarded to MFA.

IN THE MATTER OF PUBLIC ADMINISTRATOR AND COVID-19 TESTING:

Public Administrator Kathy Oliver reported that a facility in which 2 of her clients resided had asked for them to be tested, as part of a facility-wide testing. Oliver said that since these two individuals were well and asymptomatic, and they could be subjected to quarantine or restrictions on their activity should they receive a false positive result, she would not consent to having them tested.

IN THE MATTER OF ROAD CONCERNS, QUARRY SUBDIVISION:

The need for a formal drainage plan for the Quarry Subdivision was again considered; Superintendent of Roads Walter Snelson will be discussing with the engineers and the developer, Tom Sowers. Every lot line will have to have a drainage ditch and Snelson is to formulate a remedy for Flagstone Circle in particular.

IN THE MATTER OF ROAD 2170:

The Landfill Board will need an itemization of all costs with respect to repair of this road and the culvert being replaced.

IN THE MATTER OF CAMPAIGN SIGNS:

Schweikhardt said campaign signs were being damaged, defaced and stolen. It was highlighted that pursuant to RSMo 115.637 (19), "Stealing or willfully defacing, mutilating, or destroying any campaign yard sign on private..." property was a class four election offense.

IN THE MATTER OF NOVEL CORONAVIS COVID-19:

Wann mentioned that the local hospital, Phelps Health, is said to have a machine that could perform more rapid tests for SARS-CoV-2, the virus responsible for COVID-19; they are said not to be using it.

IN THE MATTER OF CARES ACT FUNDING:

The process of applying for Coronavirus Relief Funds (CRF) under the federal government's CARES Act is being updated by MRPC. The Phelps Health request for some \$1.75 million was discussed; CEO Ed Clayton may need to come speak to the Commission. Some of the frequently asked questions from the update provided by the U.S. Treasury on July 8, 2020 were explored.

IN THE MATTER OF SURPLUS TAX REQUEST:

The Commission reviewed additional documents for the request of Surplus Tax funds from the 2017 Collector's Delinquent Tax Sale of property owned at that time by Thomas J. Aaron, Jr. Local resident Joey Auxier and Phelps County Focus Staff Writer Andrew Sheeley were also present. This was property at 15443 County Road 7100, Parcel Number 71-09-3.0-07-000-000-034.000, Collector Account #9832. The surplus amount was \$7,022.48 and the Commissioners signed a letter to Treasurer Carol Green releasing these funds to Aaron per his request.

IN THE MATTER OF EMPG GRANT:

Phelps County Sheriff's Department Lt. and Emergency Management Director Mike Kirn presented a subrecipient award for the EMPG funding, through the State Emergency Management Agency (SEMA). The purpose of the EMPG Program is to make grants "...to locals in preparing for all hazards, as authorized by the Robert T. Stafford Disaster Relief and Emergency Assistance Act (42 U.S.C. 5121 et seq.). Title VI of the Stafford Act authorizes grants for the purpose of providing a system of emergency preparedness for the protection of life and property in the United States from hazards and to vest responsibility for emergency preparedness jointly in the Federal Government, States, and their political subdivisions. SEMA, through the EMPG Program, provides necessary direction, coordination, and guidance, and provides necessary assistance, as authorized in this title so that a comprehensive emergency preparedness system exists for all hazards in the state of Missouri. This award is not for Research and Development. There is no indirect cost rate for this award." In the amount of \$11,700 over a performance period from 1/1/2020 to 6/30/2021, this was approved as moved by Commissioner Stratman and seconded by Commissioner Hicks. asked if he could fulfill the function of sheriff, for which he is running unopposed, and EMD, Kirn said, "I can still do it."

IN THE MATTER OF PROSECUTOR'S SALARY INCREASE:

The Commission received and reviewed a letter from the State of Missouri, Office of Prosecution Services confirming the salary increase for the Prosecuting Attorney from \$141,640 to \$145,334, effective July 1, 2020. This is pursuant to state statute and follows the judicial salary schedule, to which it is tied, and has been adjudicated by the courts.

IN THE MATTER OF ROAD 6410:

The Commission reviewed a recent property purchase on this road.

IN THE MATTER OF NOVEL CORONAVIRUS COVID-19:

Phelps/Maries Health Department Director Ashley Wann reported that there were 55 cases of COVID-19 cumulatively for Phelps County, but only 6 active cases with one inpatient at Phelps Health who was not artificially ventilated. There was a discourse about testing and reporting. Since there has been one positive serology (which means a blood test for antibodies) out of approximately 700 in Phelps County, Wann proposed this implied that the virus had not been widespread in the county. She reported being pleased with the strategy being undertaken at S&T for returning students. Sheeley then left. Wann notified the Commission that she may resubmit her CRF application for March and April, as some of the advice has changed.

IN THE MATTER OF CITIZEN INPUT:

Richard Hashagen of Camp Brimshire visited briefly.

IN THE MATTER OF MODOT AUDITOR:

The concerns of the MoDOT Auditor, who found discrepancies between the single audit report of several grant sums and those in records kept by MoDOT, were reviewed. The clerk has plans to contact MoDOT to provide supporting documents which will explain these. One discrepancy, she said, is the result of \$2,000 in Eastern Federal Lands Oversight (administration) which appeared on a document provided by the Federal Department of Transportation to the single audit firm, which had never been remitted to the county. The other discrepancies involve incorrect totals for two Sheriff's grants through MoDOT because she took figures from the wrong column of her ledger report. MoDOT has suggested that they may not release funds for the BRO project on Road 7100 unless they obtain some satisfaction on these discrepancies. The clerk is also awaiting a return call from the State Auditor's Office audit manager for Phelps County.

IN THE MATTER OF STATE CYBER CRIME GRANT (SCCG):

PCSD Detective Shawn Hedge presented a revised Final Application for the South Central Missouri Computer Crime Task Force (SCMCCTF), State Cyber Crime Grant (SCCG). There was a slight revision downward in the grant amount to \$70,128.42, but it remained enough to cover his salary and benefits and some supplies. This was approved as moved by Commissioner Stratman and seconded by Commissioner Hicks.
