IN THE MATTER OF JAIL EXPANSION FINANCING:

Mark Grimm of Gilmore & Bell and Ernie Kost of First State Community Bank, Rolla, were present as was the Focus reporter. Sheriff Mike Kirn and PCSD Lt. Joe Taylor arrived at 0910. Grimm discussed the generalities of lease-purchase transactions. case the county will lease the underlying real estate to FSCB, which then leases the real estate and its improvements back to the county. Grimm continued to say that in Missouri, cities and counties cannot mortgage their property. This agreement spans 10 years, with 6.6 million in tax exempt debt at 4% and 2.4 million at a 5% interest rate, taxable. Presiding Commissioner Verkamp asked how this affected the ability to keep federal prisoners. Since the federal prisoners are treated as "private use", IRS rules limit the number of prisoners for the purpose of tax-exempt financing. Treasurer Carol Green entered at 0917. Commissioner Hicks asked about annual reporting and audits; Grimm said that they have 700-800 bond issues annually as a firm and of those they have 3-4 audits. Sheriff Kirn said the target for their federal prisoner census was 150. Kost emphasized the benefits of working with one bank, that is, one investor. An initial draw of \$68,000 is required to lock-in the rates. Sheriff Kirn said that the US Marshall's service in Springfield would "use all the capacity" as soon as available; this is felt an indication of the need for more capacity. There will be 105 beds for state inmates, 85 more than current. Grimm added that liens aren't permitted on county projects, but that payment performance bonds would be and the bank and county will both be named beneficiaries. Local resident Chester Kojro entered at 0930. Turning to documents, Grimm also referred to Exhibit E, the Tax-Exempt Financing Compliance Policy and Procedure (required by IRS since about 2012 on similar projects). Commissioner Hicks moved and Commissioner Auxier seconded the approval of the following order:

AN ORDER AUTHORIZING PHELPS COUNTY, MISSOURI, TO ENTER INTO A LEASE PURCHASE TRANSACTION TO FINANCE CERTAIN CAPITAL IMPROVEMENTS; AND AUTHORIZING THE EXECUTION OF CERTAIN DOCUMENTS AND ACTIONS IN CONNECTION THEREWITH.

WHEREAS, Phelps County, Missouri (the "County"), finds and determines that it is advantageous and in the best interests of the County to enter into certain transactions with First State Community Bank (the "Bank") to provide funds, together with other legally available funds of the County, to (1) construct, expand, renovate, remodel, furnish and equip the County's law enforcement center (the "Project") and (2) pay certain costs in connection with the execution and delivery of the documents approved herein; and

WHEREAS, the County owns certain real property and the improvements now or hereafter located thereon, including the real property upon which the law enforcement center is situated (the "Real Property"); and

WHEREAS, as part of the Project, the County will acquire and install certain personal property (the "Personal Property"); and

WHEREAS, in order to facilitate the foregoing and to pay the cost thereof, it is necessary and desirable for the County to take the following actions:

- 1. Enter into a Base Lease (the "Base Lease"), in substantially the form of Exhibit A, with the Bank, pursuant to which the County will lease the Real Property to the Bank;
- 2. Enter into a Lease Purchase Agreement (the "Lease"), in substantially the form of Exhibit B, with the Bank, pursuant to which the County will lease the Real Property and the Personal Property from the Bank with an option to purchase the Bank's interest therein;
- 3. Execute a Federal Tax Certificate (the "Tax Certificate"), in substantially the form of Exhibit C, which will set forth certain representations, facts, expectations, terms and conditions relating to the use and investment of the proceeds of the Tax-Exempt Portion (as defined in the Lease) of the Lease and of certain other related money, in order to establish and maintain the exclusion from gross income for federal income tax purposes of the Interest Portion (as defined in the Lease) of the Rental Payments (as defined in the Lease) attributable to the Tax-Exempt Portion of the Lease to be paid by the County, and to provide guidance for complying with the arbitrage rebate provisions of § 148(f) of the Internal Revenue Code of 1986, as amended;
- 4. Enter into an Account Control Agreement (the "Account Control Agreement"), in substantially the form of Exhibit D, with the Bank and First State Community Bank, as deposit bank, pursuant to which proceeds of the Lease will be deposited in a project account and disbursed to pay costs of the Project;
- 5. Approve a Tax-Exempt Financing Compliance Policy and Procedure (the "Compliance Procedure"), in substantially the form of Exhibit E, to promote compliance with the federal tax laws related to the Tax-Exempt Portion of the Lease and any other tax-exempt obligations currently outstanding or issued in the future; and
- 6. Approve a Tax Compliance Services Proposal (the "Tax Compliance Proposal"), in substantially the form of Exhibit F, under which the County will engage Gilmore & Bell, P.C. to assist the County in complying with the federal tax laws related to the Tax-Exempt Portion of the Lease.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNTY COMMISSION OF PHELPS COUNTY, MISSOURI, AS FOLLOWS:

- Section 1. Approval of the County Documents. The Base Lease, the Lease, the Tax Certificate, the Account Control Agreement and the Tax Compliance Proposal (collectively, the "County Documents") are hereby approved in substantially the forms submitted to and reviewed by the County Commission on the date hereof, with such changes therein as are approved by the Presiding Commissioner. The Presiding Commissioner's execution of the County Documents will be conclusive evidence of such approval. The Presiding Commissioner is hereby authorized and directed to execute and deliver the County Documents and to approve changes to the County Documents on behalf of and as the act and deed of the County. The County Clerk is hereby authorized to affix the County's seal to the County Documents and to attest said seal.
- Section 2. Approval of Compliance Procedure. The County hereby adopts the Compliance Procedure.
- Section 3. Further Authority. The County will, and the officials and agents of the County are hereby authorized and directed to, take such actions, expend such funds and execute such other documents, certificates and instruments as may be necessary or desirable to carry out and comply

with the intent of this Order and to carry out, comply with and perform the duties of the County with respect to the County Documents and the other documents authorized or approved hereby. Without limiting the generality of the foregoing, the County Commission specifically authorizes and directs the prompt payment of all closing costs relating to the County Documents.

Section 4. Severability. The sections of this Order shall be severable. If any section of this Order is found by a court of competent jurisdiction to be invalid, the remaining sections shall remain valid, unless the court finds that: (a) the valid sections are so essential to and inseparably connected with and dependent upon the void section that it cannot be presumed that the County Commission has or would have enacted the valid sections without the void one, and (b) the valid sections, standing alone, are incomplete and are incapable of being executed in accordance with the legislative intent. The invalid provision shall be omitted, and this Order shall be amended to the extent possible to conform to the original intent of the County.

Section 5. Governing Law. This Order shall be governed exclusively by and construed in accordance with the applicable laws of the State of Missouri.

Section 6. Effective Date. This Order shall be in full force and effect from and after its passage by the County Commission.

Grimm briefly discussed with the Sheriff the personal property that would be installed and asked about property and casualty insurance; Kirn left at 0940. Numerous other documents including amortization documents, account control, initial payment request forms covering title insurance and Gilmore and Bells \$4,000 fee were executed by Presiding Commissioner Verkamp. Carol Green signed as bond compliance officer. Numerous documents were executed. Grimm and Kost, followed by Taylor, left at 0955.

IN THE MATTER OF SALES TAX REVENUE:

Green presented the sales tax revenues for August which showed an 18.72% increase in the MTM comparison and 10.20% increase in the rolling twelve-month comparison. The clerk said that sales tax was up, in her opinion, because of the inflation of the currency, and thus in the price for goods; she said the State Tax Commission's declaration of a CPI of 7% for the twelve months

ending 2/1/2022 was surely an underestimate. Collector Faith Barnes entered at 1000; Green left about 1005.

IN THE MATTER OF GROUP BENEFIT SERVICES:

The Commission reviewed the benefit management report which showed \$722,215.33 in the reserve account for claim payments.

IN THE MATTER OF CITY OF ROLLA, RECEIPT OF COUNTY ARPA FUNDS:

The city of Rolla applied 1.5 years ago for a grant for a sidewalk along Highway E, which stipulates roughly a \$100,000 match from the county; this was taken under consideration. The sidewalk would extend approximately 3,000 feet from Vista Drive to Danata Street, with roughly 650 feet of this distance falling along the county portion. As moved by Commissioner Hicks and seconded by Commissioner Auxier, \$50,000 in ARPA funds contributed toward this match was approved.

IN THE MATTER OF LP GAS BIDS, AWARD:

The Commission discussed the award of the bid with Sheriff Kirn. The ability to award a bid to the "lowest and best" bidder was considered, in light of the sometimes urgent need for propane during bitter winter weather when travel is difficult. After lengthy discussion, the bid was awarded to Poe's Rural and City Gas Company, whose bid was \$1.979/gallon as moved by Commissioner Auxier and seconded by Commissioner Hicks.

In the absence or Presiding Commissioner Verkamp, the clerk appointed Joey Auxier to preside.

IN THE MATTER OF EQUIPMENT VENDOR:

Dave Burns with Fabick Caterpillar came to introduce himself to the Commission. Coroner Ernie Coverdell; Steve Jackson, general manager and Dave Laramore, project manager of NB West; and local resident Josh Brown were present, as was the Focus reporter.

IN THE MATTER OF BID, MILLING AND OVERLAYMENT OF ROADS 2110 AND 8010:

The bids received were discussed. Superintendent of Roads Mark Case and Michelle Bock of the Road and Bridge Department entered at 0915. Commissioner Hicks related the importance of Road 2110 being done in 2022, and 8010 in 2023 at the latest. Jackson said that contractors in the east were buying oil products in the midwest and this put pressure on prices. As moved by Commissioner Hicks and seconded by Commissioner Auxier, the bids were awarded to NB West. An agreement was included to "sell the county material" for site work at the new Road and Bridge facility for \$1.00 a ton and NB West would keep the millings. Case said his crew needed 3-4 weeks' notice before the work started so they could do their part of the preparation on the shoulders.

IN THE MATTER OF PRESSURE PAVING:

Case provided an update of the pressure paving projects. Collector Faith Barnes entered at 0925.

IN THE MATTER OF LOW WATER CROSSINGS:

Commissioner Hicks asked for a report on the low water crossings (LWC's) felt in need of work. Case said he would be looking at additional LWC's; he discussed these in some detail. Road 8050 is the worst one and fairly urgently needs to be dealt with. Lt. Joe Taylor of the Sheriff's Department and local resident Ray Schweikhardt entered at 0930. Commissioner Hicks said he was aware of interest from several engineering companies looking for federal grant opportunities to bundle multiple LWC's. Dan Cavender with BPJ Insurance entered at 0945 just as Laramore left. The reporter left at 0950.

IN THE MATTER OF JAIL EXPANSION:

JAIL EXPANSION, Continued:

Plans to expand the jail and the need for liability coverage, especially builder's risk, were discussed with Cavender. Taylor provided him information on the dimensions of the project, not only with respect to the addition itself (Phase I) but also the kitchen-area repurposing which will be a separate project (Phase II). Cavender said that he was being urged to provide proof of coverage by the financing entity on a more accelerated schedule than he typically encountered, but thought it understandable. Local resident Scott White entered at 0955. Cavender and Taylor left at 1010.

IN THE MATTER OF ROAD 2300:

In response to Commissioner Auxier's inquiry, White said that he wanted to modify the ditch along Road 2300. White said that the Road 2300 ditch on the east end of his parcel was never built, or had been obliterated somehow, and he faced problems with water running across the eastern point of his property. He has plans including accessing the parcel from the eastern end which may include a paved parking area; there are access points for multiple other landowners, some of which are not maintained by the county, and stormwater runoff toward a lake to the south of several properties including his, which all need to be considered in the work he hopes to do. Commissioner Hicks advised him not to alter the County's roadway and encouraged continued attempts at cooperation with his neighbors. He was further encouraged to contact the Road Department to ask about ditching along 2300, with the understanding that the Road Department is in the middle of roadwork season and may have significant scheduling concerns. After verbalizing understanding, White left at 1050.

IN THE MATTER OF CORONER'S STORAGE:

Coverdell wanted input from the Commission regarding the storage of his records. He has numerous files of documents. The clerk expressed the hope that these files, many of which are lifetime retention or permanent records, could be stored in the Courthouse. Building and grounds input will be sought; Coverdell then left.

IN THE MATTER OF ROAD 4270:

Local resident Mary Lou Long entered at 1110 to speak, again, with the Commission about her road, which she and a few other residents had visited with the Commission about in the spring. She brought some documents with her and she said, "We are taxpayers on that road, and we are not going to pay for paving it ourselves because that is your responsibility. It has been chip and sealed twice, the first time poorly, perhaps by someone that the county contracted with...nothing has been done on this road for five years." Long said that her road was maintained up to her mailbox; it was her understanding that the Post Office would not deliver along a road unless it was public.

ROAD 4270, Continued:

Commissioner Hicks said this was not true; postal deliveries occurred along private drives also. She said, "We pay taxes for the roads. This is what the taxes are for." Commissioner Auxier said, "My mother doesn't want to pay for paving your road." Commissioner Hicks also said that irrespective of previous administrations, the County did not plan to maintain private roads or driveways; however, the County's portion of Road 4270, being some 2.1 thousand feet, was to be overlain with asphalt this season. This road crosses into Dent County and is very distant for maintenance crews to travel, which argues for a more lasting surface treatment. Long was supplied with a copy of the schedule showing this; she urged the Commission to be in contact with the Dent County Commission about paving the portion of the road in that county; Commissioner Hicks said Dent County is in difficult financial straits and might not be able to do this. She requested that the Commission reach out to their Dent County counterparts one more time, and then left at 1135.

IN THE MATTER OF COURTHOUSE PARKING LOT:

IN THE MATTER OF HYPOINT SEWER AND RREC, COUNTY ARPA FUNDS REQUEST:

Ben Tipton of the Rolla Regional Economic Commission (RREC) said the group had recently been considering which direction was optimal for Rolla's expansion. Also present were local residents Ray Schweikhardt and Chester Crider, the focus reporter, Dale Martin of RREC, and Theresa Lasher of the Sheriff's Department. Tipton said the direction is likely to the east, and there is an emphasis on watershed studies which need funding. RREC has agreed to put in \$13,500; Intercounty Electric \$10,000; and RREC is appealing to the County to put in \$10,000. He estimated this would be about half of the total study cost of \$87 K. The sewershed of the Hypoint area was to the south. The city is paying for a different portion of the study. Considerations would be the type and size of industry that would be put in. Hicks wondered if the study would show that a completely new sewage treatment plant would be needed. Commissioner Auxier moved and Commissioner Hicks seconded a motion to commit the County to participate, using \$10,000 in ARPA funds. Collector Faith Barnes entered at 0910. Tipton and Martin left at 0912.

IN THE MATTER OF COLLECTOR'S TAX SALE:

Discussion by Barnes included 18 properties total with sale of 12 and 6 no bids. One parcel is post-third year sale and was not included. The total delinquent taxes and fees collected was over \$20,000; the surplus amount was over \$57,000. Barnes discussed the process at some length but emphasized the county does not 'make money' on the sale. Local resident Chester Kojro entered at 0925.

IN THE MATTER OF PINE HILL CEMETERY:

Crider reported recent vandalism, a third incident, with knocked-down headstones, scattered grave decorations and a dumped trash barrel. Local resident Gary Green used his tractor to reposition some of the headstones. A PCSD Deputy was called and came to make a report. Crider is going to speak with a local resident about using game cameras, and left about 0935.

Sheriff Kirn will dispatch a deputy; he left at 1010.

IN THE MATTER OF ABLE COMMISSION:

Zelda Shelton, Susan Birdsong and Barrett Payne of ABLE Commission said that they received a letter from the city of Rolla telling them that they will be "homeless" on 12/31/2022. County Treasurer Carol Green entered at 1012. The Holloway House had issues on inspection. ABLE is seeking temporary housing until the new PCS Senior Center opens. The city had made some suggestions of places they could temporarily reside. Payne said that they minimally needed 600 square feet, mostly Monday through Thursday; many of their activities occur elsewhere. Shelton said that Kaleidoscope had wanted to use the space in Holloway House after ABLE relocated to the new senior center; this potential use by children spurred an inspection. There are concerns regarding lead. A brainstorming session regarding potential locations ensued; Green recommended contacting local landlords Dale Wands and Gary Heavin and local realtors. Shelton said they receive \$5500/year from the city and they are to appear before the city council in October. Kojro and the ABLE members left at 1030.

IN THE MATTER OF CART FUNDS:

Green presented CART funds for the month of August. She left, and was followed after a few minutes by Schweikhardt.

IN THE MATTER OF SPECIAL SESSION OF THE GENERAL ASSEMBLY:

IN THE MATTER OF
TAX LEVY HEARING,
PHELPS COUNTY BOARD FOR THE DEVELOPMENTALLY DISABLED:

Board Chairman Gary Young and member Donna Adam were present for the hearing at 0900. The reporter was also present. The tax levy ceiling this year was 0.0686, up very slightly due to a decrease in the adjusted assessed valuation, from 0.0685 last year. The clerk discussed the origins of this, due to the adjusting process removing (county-wide) over 6 million in new construction and \$37 million in personal property. The latter was caused by the sharp increase in the Blue Book values of used motor vehicles, which assessors must follow. After adjustment the assessed value county-wide was actually down 0.1472%. Collector Faith Barnes entered at 0912. The 8 agencies funded by PCBDD were discussed. Presiding Commissioner Verkamp asked for other comments for the good of the order; hearing none, he closed the hearing. Young and Adam left as Sheriff Kirn entered at 0920.

IN THE MATTER OF COLLECTOR:

Barnes mentioned speaking with a resident who expressed his appreciation for the very courteous services he'd received from the assessor's and collector's offices. Karen Jones in the assessor's office was specifically recognized.

IN THE MATTER OF CRIME IN BEAULAH AREA:

Sheriff Kirn discussed the recent discovery of a 40-year-old deceased woman in a very primitive settlement south of Highway K near Beulah. An extensive discussion of the absentee land owner and his practices ensued; these seem to promote severe social disorganization for the population drawn to live there. The reporter believed conspiracy theories about coming societal collapse and a fixation over living "off the grid", as well as an obsession for being self-sufficient, were responsible.

IN THE MATTER OF SENIOR COMPANIONS:

Memoranda of Understanding between St. James Living Center and the Phelps County Senior Companions were approved as moved by Commissioner Auxier and seconded by Commissioner Hicks.

IN THE MATTER OF TAX LEVY HEARING, COUNTY REVENUE AND ROAD AND BRIDGE LEVIES:

COUNTY REVENUE AND ROAD AND BRIDGE LEVIES, Continued:

Due to prior discussions the hearing did not begin until 1030. The clerk proposed levies of 0.0926 and 0.0968 for County Revenue and Road and Bridge, respectively. The ceilings had been increased for County Revenue from 0.2663 to 0.2667 and for Road and Bridge from 0.1902 to 0.1905 from 2021 to 2022, due to a miniscule percentage decrease in the adjusted year to year assessed valuation. The clerk calculated the 50% sales tax roll back and additionally the roll back not taken in the prior year because the first 6 month's sales tax---used as of necessity in an August calculation---was less than half of the entire sales tax revenue for those two funds in 2021. She has been making this additional roll back for a number of years now. This is what produced the levies she recommended. Given the roll back, they were the maximum allowable to the Commission. As moved by Commissioner Hicks and seconded by Commissioner Auxier, the proposed tax levies were approved. No one aside from the reporter was present for the hearing.

IN THE MATTER OF PROPOSED SUBDIVISION PLAT:

Local resident Katrina Heitman entered with a subdivision plat for The Nest at Quail Run Estates, this will be reviewed and potentially approved by the Commissioners at their next meeting. Phelps/Maries Health Department Director Ashley Campbell entered at 1135 just as Heitman left.

IN THE MATTER OF HEALTH DEPARTMENT GRANTS:

\$76,xxx for Healthy Families grant was approved as moved by Commissioner Auxier and seconded by Commissioner Hicks, as was the MOU between DHSS and PCHD. A participation agreement from 10/1/2022 through 9/30/2025 for environmental childcare inspections was discussed briefly by Campbell; the rates have not increased for a long time and Campbell says she and several other directors have requested this. As moved by Commissioner Auxier and seconded by Commissioner Hicks, this was approved.

IN THE MATTER OF CERF CREDITS AND COUNTY PAYROLL:

In 2018 the County began making 1% of the total 4% contribution of full-time employees to CERF. Employees are not vested until 8 years of service; those who leave employment prior to this may have their personal contributions returned to them. The 1% County share in these cases has amounted to over \$27,000 in 4.5 years, and the clerk wanted the Commission to be aware that Deputy Clerk Lisa Dowdy (HR) was using these credits, within the same fund and department (if applicable) to defray the payroll costs to the county going forward. She had been able to apply over \$23,000 of the credits to date, since 1/31/2019, keeps a careful spreadsheet of the amounts, and balances to CERF.

IN THE MATTER OF FREIGHTLINER TRUCK:

Focus reporters Andrew Sheeley and Josh Sumner were present as was Andy Helms, former employee of the Juvenile Division and the unopposed, November 2022, Pulaski County Western District Commissioner candidate. Matt Pace with Truck Centers Inc., a Freightliner and Western Star dealer, and Scott Boyer with Viking Cives Midwest Sales, as well as Superintendent of Roads Mark Case and Michelle Bock of the Road Department entered. Case provided details on how vaque and indefinite the build date and delivery of an International Truck would be. Pace said his firm deals with the same supply chain problems as their competitors, but he estimated that he would be able to get a truck chassis ready by mid-2023 and Boyer would need 90 days to complete the body; they have trouble obtaining hydraulic systems. Boyer said they are on the state MoDOT contract, as is Pace. Commissioner Hicks asked about any repercussions of withdrawal from a Scheppers agreement. The 2015 International Maxforce truck with nearly no miles on the \$30,xxx new motor around 160 thousand miles on the chassis will not be taken by Scheppers in trade (despite them being an International dealer) and Pace said he believed he was making a generous trade-in allowance for this truck. He always has to put a great deal of work into these trucks and almost sees the trade-in as a liability; he would understand the decision on the part of the County to auction off the old truck online. Presiding Commissioner Verkamp suggested the Road Department contacting Scheppers via email to try to document the intent to withdraw from the agreement to assess their response. Pace and Boyer left at 0925; just as local resident Chester Kojro and Collector Faith Barnes entered; Barnes left after scanning the agenda.

IN THE MATTER OF ROAD WORK:

Case and the Commission engaged in a discussion over the statue of multiple projects and some equipment issues.

IN THE MATTER OF COMMISSARY BANK ACCOUNT:

Theresa Lasher of the Sheriff's Department entered with a letter from the Sheriff stating that the new Commissary and Inmate Banking services company would insist on, and be granted, a new banking account so funds from the prior vendor would not be comingled. Lasher said she is taking steps to make sure that the outgoing vendor will not "freeze" the funds say, over a weekend, and prevent her from accessing them. She writes checks for the inmates.
