IN THE MATTER OF EDGAR SPRINGS SCHOOL:

Sheriff Kirn was to appear to present information which was initially of some concern regarding a new facility with a faith-based approach to addiction problems, which was to be in the immediate vicinity of the school. However, the message was relayed that he had been in contact with the pastor there and there was felt to be less cause for concern. Also present were Superintendent of Roads Mark Case, Michelle Bock of the Road and Bridge Department, Mike Scott and Tonya Greven of BPJ Insurance, Cameron Schweiss and Josh Kendle of Archer Elgin, Collector Faith Barnes and the Focus reporter.

IN THE MATTER OF SENIOR COMPANIONS:

Presiding Commissioner Verkamp announced he would be making an appearance at the recognition program on September 10.

IN THE MATTER OF SECURE RURAL SCHOOLS (SRS) ALLOCATION FOR SPECIAL PROJECTS:

The Commission had received communication from Beth Dillon at the state's Office of Administration, Division of Accounting, regarding the Secure Rural Schools and Community Self-Determination act of 2000 (SRS). SRS provides for payments to states to be distributed to counties in which eligible federal lands are situated, chiefly U.S. Forest Service lands. Participating counties receiving a share of the state's payment that is greater than \$100,000 must make an election to allocate the payment among the titles in the authorizing law by September 15, 2022. Without such an election, the county would see 15-20% of this allocation returned back to the U.S. Treasury. Dillon's email said that the "...election process has not been done for some time, but the Federal government is requiring that it be completed again this year." The County was informed that a 15% to 20% allocation must be established for special projects, which could be devoted to county projects ("Title III"). As moved by Commissioner Auxier, seconded by Commissioner Hicks, the Commission elected to reserve, under Title III, 20% of the annual payment for road improvements. These would include, but not be limited to, road maintenance, improvement of low water crossings, stormwater mitigation of various types, purchase of rock and asphalt or asphalt products, purchase of ice melt, or the acquisition of needed road equipment.

IN THE MATTER OF ANNUAL LAGERS MEETING:

ANNUAL LAGERS MEETING:

Dowdy, an HR Deputy Clerk, mentioned that a LAGERS employer delegate could be the incoming clerk Laura Johnson and she was interested in attending. As moved by Commissioner Auxier and seconded by Commissioner Hicks, her designation was approved.

IN THE MATTER OF EMPLOYEE MEDICAL INSURANCE:

Scott and Greven wanted to discuss possible bidding of the medical insurance for employees. The discussion included the amount of reserve needed; BPJ believing two years of data would be needed to prepare a bid; Group Benefit Services use of Aetna for billing which does repricing; retirees remaining on insurance. Incentives to employees for obtaining, for example, MRI services at a cheaper facility, were discussed.

IN THE MATTER OF ROAD AND BRIDGE FACILITY:

Schweiss and Kendle provided updated documents and drawings including the topographic survey and demolition plan, overall site and grading plans, the equipment shed layout and the upper and lower level plans for the main facility structure. Extensive discussion ensued on multiple aspects. Case asked about a sprinkler system; there are no County codes. Archer Elgin said they would be obligated to design to code "even if Phelps County has no codes." Fire suppression strategy was discussed, perhaps with accessing city water supply and the engineering firm will look into this further. Schweiss and Kendle then left.

Treasurer Carol Green entered at 0915 and presented the August sales tax receipts. County 0.5% sales tax was \$339,053.59, down 12.34% in the month-to-month comparison, but still a 7.57% increase in the rolling twelve-month comparison.

IN THE MATTER OF IFS INVOICE:

The Commission and Green discussed ways to handle the roughly \$275,000 final invoice for the courthouse HVAC controls project; since much of the Public Facilities Authority Fund (Fund 900) is invested in CD a reimbursable transfer of funds from County Revenue (Fund 200) will occur for payment. Green left at 0925.

IN THE MATTER OF MRPC TECHNICAL ASSISTANCE CONTRACT:

As moved by Commissioner Hicks and seconded by Commissioner Auxier the agreement was approved. Local resident Chester Kojro entered at 0930. Presiding Commissioner Randy Verkamp recounted the history of some of the grant projects undertaken for the

IN THE MATTER OF PUBLIC ADMINISTRATOR:

Dana Sooter entered at 0935 on an unscheduled visit to notify the Commission of additional time required of her part-time employee such that she may exceed the 1,000-hour threshold for CERF eligibility. She is being assigned more decedent's estates and spent some time discussing the burdens involved. Michelle Bock of the Road Department entered at 0940. Sooter left at 0945.

IN THE MATTER OF ROAD 4270:

Upon Bock's inquiry, Commissioner Hicks said that Dent County is either going to rebuild their part of Road 4270 and double chip it or rebuild and pay Phelps County for the cost of asphalt. Dent's estimate for asphalt is \$10,000 and Superintendent of Roads Mark Case believes it is much higher, perhaps \$20,000 or more. Commissioner Hicks said that regardless, Dent County will ditch and install several culverts; ten thousand will not cover the cost of ½ mile of double chip. Two of the property owners are anxious to pave all the way to 72 (within Dent, in other words). The Dent county segment will not accommodate an 18-foot road; perhaps 16 and perhaps less. Commissioner Hicks said, "So, we're still in negotiations," and Dent County will give Phelps their share of the CART funds, which will be far less than any annual maintenance cost. Bock said there is nothing Recorder Robin Kordes could find regarding the easterly terminus of the road being a county road; Commissioner Hicks said a portion had been chip and sealed north of the cul-de-sac seen on GIS. Associate Commissioner Gary Larson of Dent County called and was put on speaker phone; he was told that the cost for 2418 feet at 16 feet wide would be very close to \$34,000; there is a landowner who may contribute as much as \$18,000. Larson said Dent County was prepared to contribute \$22,000; the call ended at 1008. In 2000 three landowners contributed 1490, 750 and 1241 feet, respectively, for chip and seal, totaling 3482. Dent County contributed 6,388.80 to the cost, which was (roughly?) half. A lengthy discussion ensued of what constituted the County's portion of the road. Legal counsel may be needed.

IN THE MATTER OF ROAD EQUIPMENT:

Bock notified the Commission that lack of response from Scheppers regarding the terms of an expected dump truck order was due to the company's involvement in buy-out negotiations with another company; the order had been successfully cancelled without penalty and a Freightliner vehicle has been ordered.

The clerk inquired about an award notification or letter for NB West; the Commission minutes of 6/23/2022 will be sent.

IN THE MATTER OF MRDC:

Commissioner Hicks reported that a roughly \$125,000 small business loan have been approved for a manufacturer in Dixon,  ${\tt MO.}$

IN THE MATTER OF GASCONADE RIVER ACCESS:

A recent pre-bid meeting held for the river access planned near Jerome was discussed by Commissioner Hicks. The Focus reporter was also present.

IN THE MATTER OF FOREST LAKES SUBDIVISION STOPSIGNS:

Due to requests by residents of the Forest Lakes subdivision, stop signs are to be installed at the easterly terminus of Forest Lake Drive with the Road 3110 intersection; at the southerly-facing terminus of Forest Lake Drive with its intersection with Road 3040 as well as at the northern end of Wildwood Lane where it intersects Road 3040.

IN THE MATTER OF MISSOURI STATE CORONER'S TRAINING FUND:

The clerk reported on this fund, which dated to the passage of HB 2046 in 2020 and was specified in RSMo 58.208. This statute provided that \$1 of the fee collected for any death certificate issued under RSMo 193.265 was to be deposited into the Missouri State Coroner's Training Fund (MSCTF). The statute specified that any moneys remaining in the fund over \$500,000 were to be deposited into the state's general revenue fund; since October, 2020 the county has deposited over \$8,600 in the fund. The clerk reported that as of 8/31/2022 there was nearly \$603,000 in the fund according to State Treasurer Scott Fitzpatrick's chief of staff, who also said the funds were "swept" into the state's general fund biennially and this would next occur after June 30, 2023. Because the coroner has requested funding for equipment upgrades, an inquiry has been made of the fund to determine whether it could be a revenue source. The reporter left as local resident Chester Kojro entered.

IN THE MATTER OF ARPA FUNDS AND U.S. TREASURY GUIDANCE:

National Association of Counties (NaCO) had, through Missouri Association of Counties (MAC), reached out to counties regarding efforts at reinstatement of advising provided by the U.S. Treasury for use of ARPA funds. Believing that Phelps County's utilization of Meramec Regional Planning Commission (MRPC) in administering the ARPA funds was sufficient toward this end, there was no action taken with respect to advocacy for federal legislation in this matter.

Commissioner Auxier wanted a traffic count of Road 4160.

IN THE MATTER OF COURTHOUSE SECURITY:

25th Circuit Presiding Judge Beger, Circuit Clerk Sonja Childers, Chief Deputy Clerk and unopposed candidate for Circuit Clerk Marlaina Wallace, Sheriff Mike Kirn, PCSD Captain Rick Hope and Head Bailiff Chris Reeder entered at 1030 just as Kojro left. Beger began by saying, "We'd like to have metal detectors at the front door" and Kirn said the issue would be staffing; at least 2 bailiffs would be required on the door at all times; he believes this to imply the need for four additional people for whom there will be benefit costs as well, since "at certain times there would be four courtrooms" in use, all of which would need their own bailiff. Kirn said the equipment would cost roughly \$35,000. Subsequently there was a lengthy discussion of the handicapped access and the layout of the vestibule as well as the placement of the equipment. Reeder said shifts would have to be staggered; Kirn expressed concern for excessive comp time and believes a year will be needed to secure staffing. Then, POST-certified versus non-certified staffing was deliberated upon. Beger asked if barriers could be erected to get courthouse visitors accustomed to the changes in entry; he stated courtroom security should really convert to courthouse security. Kirn said, when costs were mentioned, that he objected to shouldering all the cost, believing half was more his share. Furthermore, Kirn suggested ordering the equipment and beginning on the physical modifications, then working on personnel. Local resident Ray Schweikhardt entered at 1105. Fire department input was mentioned; Beger, Childers, Wallace and Reeder then left at 1110.

IN THE MATTER OF JAIL EXPANSION:

Kirn spoke of the construction bid, and described some aspects of it as "vague" of necessity because some of the subcontractors were still providing input. Commissioner Auxier advocated the addition of real, not liquidated, damages to the contract.

IN THE MATTER OF ROAD VACATION IN JEROME:

Local resident Karen Peterman of Jerome was present as was the Focus reporter. Michelle Bock of the Road Department entered at 0902; Grant Wilson, field representative for Congressman Jason Smith, entered at 0903. Peterman recounted that after being in contact with her bank and a title company, her house located at 22715 Cherry Street was found to be encroaching on an alley which was the property of Phelps County. This east-west alleyway was never constructed as a road, though used by individuals living along it to access their property. Both her garage and her house are encroaching, and she asked the Commissioners for their experience. Collector Faith Barnes entered at 0910. Presiding Commissioner Verkamp spoke of the "adverse possession" of county-owned property upon which a structure has been built and existed for some time. Peterman owns the lots north as well as south of the alleyway; the northern lot is a circle drive. Though the eastern lot lines fall on the same north-south line, the southern lot extends further to the west. An alternative such as vacating only that part of the alleyway shared between her two lots was discussed, though this would leave the garage encroaching on unvacated alleyway. Barnes left at 0920; after more discussion, Peterman left at 0930, having been encouraged to speak with the neighbors and to consider legal counsel.

She is concerned about vacation of Road 6010 as she says this is the E911 address for her family's land and, in addition, is the main or the only access to the land when there is flooding of the Little Piney and/or its tributary, the Kitchen Branch. A property between the Cahill land and Highway 63 belongs to the petitioner. Cahill expressed consternation at the petitioner's gating the road, such that once she was "unable to leave" when she attempted to exit after dark. Her concern, expressed several times, was that once the road was vacated, there would not be any way to work it out with the petitioner. The discussion continued at some length thereafter, including a listing of the pros and cons.

Commissioner Hicks provided news that the MCEC had recently undergone an audit and there were no negative findings.
